SYNOPSIS AS INTRODUCED:

625 ILCS 5/3-694 new

Amends the Illinois Vehicle Code. Provides for the issuance of ABATE special license plates for passenger vehicles of the first division, motor vehicles of the second division weighing not more than 8,000 pounds, and motorcycles. Provides that, in addition to the appropriate registration fees, an applicant for the special plates shall be charged a fee of \$15 at original issuance and \$2 at each renewal. Provides that the additional fees shall be deposited into the Secretary of State Special License Plate Fund. Effective January 1, 2012.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Illinois Vehicle Code is amended by adding
Section 3-694 as follows:

6 (625 ILCS 5/3-694 new)

7 <u>Sec. 3-694. ABATE license plate.</u>

(a) The Secretary, upon receipt of an application made in 8 9 the form prescribed by the Secretary of State, may issue 10 special registration plates designated as ABATE license plates. The special plates issued under this Section shall be 11 12 affixed only to passenger vehicles of the first division, motor vehicles of the second division weighing not more than 8,000 13 14 pounds, and motorcycles. If the Secretary of State issues the special plates for passenger vehicles of the first division or 15 16 motor vehicles of the second division weighing not more than 17 8,000 pounds, then the Secretary of State must also make the special plates available for motorcycles. Plates issued under 18 19 this Section shall expire according to the multi-year procedure 20 established by Section 3-414.1 of this Code.

(b) The design and color of the plates shall be wholly
 within the discretion of the Secretary of State. The Secretary
 of State may, in his or her discretion, allow the plates to be

1	issued as vanity plates or personalized in accordance with
2	Section 3-405.1 of this Code. The Secretary of State shall
3	prescribe stickers or decals as provided under Section 3-412.
4	(c) An applicant shall be charged a \$15 fee for original
5	issuance in addition to the applicable registration fee. For
6	each registration renewal period, a \$2 fee, in addition to the
7	appropriate registration fee, shall be charged. The additional
8	fees shall be deposited into the Secretary of State Special
9	License Plate Fund.

Section 99. Effective date. This Act takes effect January 11 1, 2012.
