Upon issuance of any order of protection, the clerk shall immediately, or on the next court day if an emergency order is issued in accordance with subsection (c) of Section 112A-17, (i) enter the order on the record and file it in accordance with the circuit court procedures and (ii) provide a file stamped copy of the order to respondent, if present, and to petitioner.
- (b) Filing with sheriff. The clerk of the issuing judge shall, or the petitioner may, on the same day that an order of protection is issued, file a copy of that order with the sheriff or other law enforcement officials charged with maintaining Department of State Police records or charged with serving the order upon respondent. If the order was issued in accordance with subsection (c) of Section 112A-17, the clerk shall on the next court day, file a certified copy of the order with the Sheriff or other law enforcement officials charged

1 with maintaining Department of State Police records.

- (c) Service by sheriff. Unless respondent was present in court when the order was issued, the sheriff, other law enforcement official or special process server shall promptly serve that order upon respondent and file proof of such service, in the manner provided for service of process in civil proceedings. Instead of serving the order upon the respondent, however, the sheriff, other law enforcement official, er special process server, or other persons defined in Section 112A-22.10 may serve the respondent with a short form notification as provided in Section 112A-22.10. If process has not yet been served upon the respondent, it shall be served with the order or short form notification if such service is made by the sheriff, other law enforcement official, or special process server.
- (c-5) If the person against whom the order of protection is issued is arrested and the written order is issued in accordance with subsection (c) of Section 112A-17 and received by the custodial law enforcement agency before the respondent or arrestee is released from custody, the custodial law enforcement agent shall promptly serve the order upon the respondent or arrestee before the respondent or arrestee is released from custody. In no event shall detention of the respondent or arrestee be extended for hearing on the petition for order of protection or receipt of the order issued under Section 112A-17 of this Code.

- (d) Extensions, modifications and revocations. Any order extending, modifying or revoking any order of protection shall be promptly recorded, issued and served as provided in this Section.
  - (e) Notice to health care facilities and health care practitioners. Upon the request of the petitioner, the clerk of the circuit court shall send a certified copy of the order of protection to any specified health care facility or health care practitioner requested by the petitioner at the mailing address provided by the petitioner.
- (f) Disclosure by health care facilities and health care practitioners. After receiving a certified copy of an order of protection that prohibits a respondent's access to records, no health care facility or health care practitioner shall allow a respondent access to the records of any child who is a protected person under the order of protection, or release information in those records to the respondent, unless the order has expired or the respondent shows a certified copy of the court order vacating the corresponding order of protection that was sent to the health care facility or practitioner. Nothing in this Section shall be construed to require health care facilities or health care practitioners to alter procedures related to billing and payment. The health care facility or health care practitioner may file the copy of the order of protection in the records of a child who is a protected person under the order of protection, or may employ

- any other method to identify the records to which a respondent is prohibited access. No health care facility or health care practitioner shall be civilly or professionally liable for reliance on a copy of an order of protection, except for willful and wanton misconduct.
  - (q) Notice to schools. Upon the request of the petitioner, within 24 hours of the issuance of an order of protection, the clerk of the issuing judge shall send a certified copy of the order of protection to the day-care facility, pre-school or pre-kindergarten, or private school or the principal office of the public school district or any college or university in which any child who is a protected person under the order of protection or any child of the petitioner is enrolled as requested by the petitioner at the mailing address provided by the petitioner. If the child transfers enrollment to another day-care facility, pre-school, pre-kindergarten, school, public school, college, or university, the petitioner may, within 24 hours of the transfer, send to the clerk written notice of the transfer, including the name and address of the institution to which the child is transferring. Within 24 hours of receipt of notice from the petitioner that a child is transferring to another day-care facility, pre-school, pre-kindergarten, private school, public school, college, or university, the clerk shall send a certified copy of the order to the institution to which the child is transferring.
    - (h) Disclosure by schools. After receiving a certified copy

of an order of protection that prohibits a respondent's access 1 2 to day-care facility, pre-school, records, neither a 3 pre-kindergarten, public or private school, college, university nor its employees shall allow a respondent access to 5 a protected child's records or release information in those records to the respondent. The school shall file the copy of 6 the order of protection in the records of a child who is a 7 protected person under the order of protection. When a child 8 9 who is a protected person under the order of protection 10 transfers t.o another day-care facility, pre-school, 11 pre-kindergarten, public or private school, college, or 12 university, the institution from which the child is transferring may, at the request of the petitioner, provide, 13 14 within 24 hours of the transfer, written notice of the order of protection, along with a certified copy of the order, to the 15 16 institution to which the child is transferring.

- (7.13) if convicted of a sex offense as defined in Section 2 of the Sex Offender Registration Act committed on or after January 1, 2010 (the effective date of Public Act 96-362) that requires the person to register as a sex offender under that Act, may not knowingly use any computer scrub software on any computer that the sex offender uses;

- (9) obtain permission of an agent of the Department of Corrections before changing his or her residence or employment;

- (10) consent to a search of his or her person, property, or residence under his or her control;
- (11) refrain from the use or possession of narcotics or other controlled substances in any form, or both, or any paraphernalia related to those substances and submit to a urinalysis test as instructed by a parole agent of the Department of Corrections;
- (12) not frequent places where controlled substances are illegally sold, used, distributed, or administered;
- (13) not knowingly associate with other persons on parole or mandatory supervised release without prior written permission of his or her parole agent and not associate with persons who are members of an organized gang as that term is defined in the Illinois Streetgang Terrorism Omnibus Prevention Act;
- (14) provide true and accurate information, as it relates to his or her adjustment in the community while on parole or mandatory supervised release or to his or her conduct while incarcerated, in response to inquiries by his or her parole agent or of the Department of Corrections;
- (15) follow any specific instructions provided by the parole agent that are consistent with furthering conditions set and approved by the Prisoner Review Board or by law, exclusive of placement on electronic detention, to achieve the goals and objectives of his or her parole or mandatory supervised release or to protect the public.

These instructions by the parole agent may be modified at any time, as the agent deems appropriate;

- (16) if convicted of a sex offense as defined in subsection (a-5) of Section 3-1-2 of this Code, unless the offender is a parent or guardian of the person under 18 years of age present in the home and no non-familial minors are present, not participate in a holiday event involving children under 18 years of age, such as distributing candy or other items to children on Halloween, wearing a Santa Claus costume on or preceding Christmas, being employed as a department store Santa Claus, or wearing an Easter Bunny costume on or preceding Easter; and

- (11) not patronize any business providing sexually stimulating or sexually oriented entertainment nor utilize "900" or adult telephone numbers;
- (12) not reside near, visit, or be in or about parks, schools, day care centers, swimming pools, theaters, or any other places where minor children congregate without advance approval of an agent of the Department of Corrections and immediately report any incidental contact with minor children to the Department;
- (13) not possess or have under his or her control certain specified items of contraband related to the incidence of sexually offending as determined by an agent of the Department of Corrections;
- (14) may be required to provide a written daily log of activities if directed by an agent of the Department of Corrections:

- supervised release is to be served shall be communicated to the person in writing prior to his release, and he shall sign the same before release. A signed copy of these conditions, including a copy of an order of protection where one had been issued by the criminal court, shall be retained by the person and another copy forwarded to the officer in charge of his supervision.
  - (d) After a hearing under Section 3-3-9, the Prisoner Review Board may modify or enlarge the conditions of parole or mandatory supervised release.
  - (e) The Department shall inform all offenders committed to the Department of the optional services available to them upon release and shall assist inmates in availing themselves of such optional services upon their release on a voluntary basis.

  - (d) Extensions, modifications and revocations. Any order extending, modifying or revoking any order of protection shall be promptly recorded, issued and served as provided in this Section.
  - (e) Notice to schools. Upon the request of the petitioner, within 24 hours of the issuance of an order of protection, the clerk of the issuing judge shall send a certified copy of the order of protection to the day-care facility, pre-school or pre-kindergarten, or private school or the principal office of the public school district or any college or university in which any child who is a protected person under the order of protection or any child of the petitioner is enrolled as requested by the petitioner at the mailing address provided by the petitioner. If the child transfers enrollment to another day-care facility, pre-school, pre-kindergarten, private school, public school, college, or university, the petitioner may, within 24 hours of the transfer, send to the clerk written notice of the transfer, including the name and address of the institution to which the child is transferring. Within 24 hours of receipt of notice from the petitioner that a child is transferring to another day-care facility, pre-school, pre-kindergarten, private school, public school, college, or university, the clerk shall send a certified copy of the order

1 to the institution to which the child is transferring.

- (f) Disclosure by schools. After receiving a certified copy of an order of protection that prohibits a respondent's access records, neither a day-care facility, pre-school, pre-kindergarten, public or private school, college, or university nor its employees shall allow a respondent access to a protected child's records or release information in those records to the respondent. The school shall file the copy of the order of protection in the records of a child who is a protected person under the order of protection. When a child who is a protected person under the order of protection transfers to another day-care facility, pre-school, pre-kindergarten, public or private school, college, university. the institution from which the transferring may, at the request of the petitioner, provide, within 24 hours of the transfer, written notice of the order of protection, along with a certified copy of the order, to the institution to which the child is transferring.
  - (g) Notice to health care facilities and health care practitioners. Upon the request of the petitioner, the clerk of the circuit court shall send a certified copy of the order of protection to any specified health care facility or health care practitioner requested by the petitioner at the mailing address provided by the petitioner.
- (h) Disclosure by health care facilities and health care practitioners. After receiving a certified copy of an order of

protection that prohibits a respondent's access to records, no 1 2 health care facility or health care practitioner shall allow a respondent access to the records of any child who is a 3 protected person under the order of protection, or release 5 information in those records to the respondent, unless the 6 order has expired or the respondent shows a certified copy of 7 the court order vacating the corresponding order of protection that was sent to the health care facility or practitioner. 8 9 Nothing in this Section shall be construed to require health 10 facilities or health care practitioners to alter 11 procedures related to billing and payment. The health care 12 facility or health care practitioner may file the copy of the 13 order of protection in the records of a child who is a 14 protected person under the order of protection, or may employ 15 any other method to identify the records to which a respondent 16 is prohibited access. No health care facility or health care practitioner shall be civilly or professionally liable for 17 reliance on a copy of an order of protection, except for 18 willful and wanton misconduct. 19

23 (a) Instead of personal service of an order of protection 24 under Section 222, a sheriff, other law enforcement official, 25 or special process server, or personnel assigned by the

- 1 Department of Corrections to investigate the alleged
- 2 misconduct of committed persons or alleged violations of a
- 3 parolee's or releasee's conditions of parole or mandatory
- supervised release may serve a respondent with a short form 4
- notification. The short form notification must include the 5
- 6 following items:
- 7 (1) The respondent's name.
- 8 (2) The respondent's date of birth, if known.
- 9 (3) The petitioner's name.
- 10 (4) The names of other protected parties.
- 11 (5) The date and county in which the order of 12 protection was filed.
- 13 (6) The court file number.
- 14 (7) The hearing date and time, if known.
- 15 (8) The conditions that apply to the respondent, either 16 in checklist form or handwritten.
- 17 (9) The name of the judge who signed the order.
- (b) The short form notification must contain the following 18 19 notice in bold print:
- 20 "The order of protection is now enforceable. You must report to the office of the sheriff or the office of the 21 22 circuit court in (name of county) County to obtain a copy 23 of the order of protection. You are subject to arrest and may be charged with a misdemeanor or felony if you violate 24 25 any of the terms of the order of protection."
- 26 (c) Upon verification of the identity of the respondent and

- 1 the existence of an unserved order of protection against the
- 2 respondent, a sheriff or other law enforcement official may
- detain the respondent for a reasonable time necessary to
- 4 complete and serve the short form notification.
- 5 (d) When service is made by short form notification under
- 6 this Section, it may be proved by the affidavit of the person

- 9 (e) The Attorney General shall provide adequate copies of
