Section 5. The Illinois Vehicle Code is amended by changing

Sec. 3-808.1. (a) Permanent vehicle registration plates
shall be issued, at no charge, to the following:

9 1. Vehicles, other than medical transport vehicles, 10 owned and operated by the State of Illinois or by any State 11 agency financed by funds appropriated by the General 12 Assembly;

2. Special disability plates issued to vehicles owned
and operated by the State of Illinois or by any State
agency financed by funds appropriated by the General
Assembly.

(b) Permanent vehicle registration plates shall be issued,for a one time fee of \$8.00, to the following:

Vehicles, other than medical transport vehicles,
 operated by or for any county, township or municipal
 corporation.

3. Beginning with the 1991 registration year,
 county-owned vehicles operated by or for any county sheriff
 and designated deputy sheriffs. These registration plates
 shall contain the specific county code and unit number.

5 4. All-terrain vehicles owned by counties, townships, or municipal corporations and used for law enforcement 6 purposes when the Manufacturer's Statement of Origin is 7 8 accompanied with a letter from the original manufacturer or 9 a manufacturer's franchised dealer stating that this 10 all-terrain vehicle has been converted to a street worthy 11 vehicle that meets the equipment requirements set forth in 12 Chapter 12 of this Code.

5. Beginning with the 2001 registration year, municipally-owned vehicles operated by or for any police department. These registration plates shall contain the designation "municipal police" and shall be numbered and distributed as prescribed by the Secretary of State.

with the 2012 18 (C) Beginning registration year, 19 county-owned vehicles operated by or for any county sheriff and designated deputy sheriffs that have been issued registration 20 plates under subsection (b) of this Section shall be exempt 21 22 from any fee for the transfer of registration from one vehicle 23 to another vehicle.
