A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1 The following named amounts, or so much
6 thereof as may be necessary, respectively, for the objects
7 and purposes hereinafter named, are appropriated to the Board
8 of the Trustees of Southern Illinois University to meet
9 ordinary and contingent expenses for the fiscal year ending
10 June 30, 2013:

11 Payable from the Education Assistance Fund:

12	For Personal Services, including payment	
13	to the university for personal services	
14	costs incurred during the fiscal year	
15	and salaries accrued but unpaid to academic	
16	personnel for personal services rendered	
17	during the academic year 2012-2013	197,712,000
18	For State Contributions to Social	
19	Security, for Medicare	2,346,700
20	For Group Insurance	3,060,000
21	For Contractual Services	9,667,200

1	For Travel	36,600
2	For Commodities	902,800
3	For Equipment	1,006,200
4	For Telecommunications Services	1,507,300
5	For Operation of Automotive Equipment	<u>633,200</u>

7 Section 5. The sum of \$22,000, or so much thereof as may
8 be necessary, is appropriated from the State College and
9 University Trust Fund to the Board of Trustees of Southern
10 Illinois University for scholarship grant awards, in
11 accordance with Public Act 91-0083.

12 Section 10. The sum of \$1,250,000, or so much thereof as
13 may be necessary, is appropriated from the General
14 Professions Dedicated Fund to the Board of Trustees of
15 Southern Illinois University for all costs associated with
16 the development, support or administration of pharmacy
17 practice education or training programs at the Edwardsville
18 campus.

19 Section 15. The sum of \$1,200,000, or so much thereof as
20 may be necessary, is appropriated from the Education
21 Assistance Fund to the Board of Trustees of Southern Illinois
22 University for all costs associated with the SimmonsCooper

1 Cancer Center.

2 Section 99. Effective date. This Act takes effect July 1,
3 2012.
