SYNOPSIS AS INTRODUCED:

805 ILCS 105/103.05

from Ch. 32, par. 103.05

Amends the General Not For Profit Corporation Act of 1986. Allows cooperatives that own and operate agriculture-based biogas (anaerobic digester) systems to organize as a non-profit. Activities of the cooperatives may include the marketing and sale of biogas system products including but not limited to methane gas, electricity, and compost. Effective immediately.

Be it enacted by the People of the State of Illinois, 2 represented in the General Assembly: 3

- (30) The administration and operation of an organization for the purpose of assisting low-income consumers in the acquisition of utility and telephone services.
- (31) Any purpose permitted to be exempt from taxation under Sections 501(c) or 501(d) of the United States Internal Revenue Code, as now in or hereafter amended.
- (32) Any purpose that would qualify for tax-deductible gifts under the Section 170(c) of the United States Internal Revenue Code, as now or hereafter amended. Any such purpose is deemed to be charitable under subsection (a)(1) of this Section.
 - (33) Furnishing of natural gas on a cooperative basis.
- (34) Ownership and operation of agriculture-based biogas (anaerobic digester) systems on a cooperative basis including the marketing and sale of products produced from these, including but not limited to methane gas, electricity, and compost.
- (b) A corporation may be organized hereunder to serve in an

area that adjoins or borders (except for any intervening 1 2 natural watercourse) an area located in an adjoining state intended to be similarly served, and the corporation may join 3 any corporation created by the adjoining state having an organized 5 purpose and as a not-for-profit corporation. Whenever any corporation organized under this Act 6 7 so joins with a foreign corporation having an identical 8 purpose, the corporation shall be permitted to do business in 9 Illinois as one corporation; provided (1) that the name, bylaw 10 provisions, officers, and directors of each corporation are 11 identical, (2) that the foreign corporation complies with the 12 provisions of this Act relating to the admission of foreign 13 corporation, and (3) that the Illinois corporation files a statement with the Secretary of State indicating that it has 14 15 joined with a foreign corporation setting forth the name 16 thereof and the state of its incorporation.
