Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 8 "Department" means the Department of Insurance.
- 9 "Director" means the Director of Insurance.
- 10 "Road hazard" means a hazard that is encountered while

- 12 potholes, rocks, wood debris, metal parts, glass, plastic,
- 13 curbs, and composite scraps.

14 "Service Contract" means a contract or agreement whereby a service contract provider undertakes for a specified period of 15 16 time, for separate and identifiable consideration, to perform 17 the repair, replacement, or maintenance, or indemnification for such services, of any automobile, system, or consumer 18 19 product in connection with the operational or structural 20 failure due to a defect in materials or workmanship, or normal 21 wear and tear, with or without additional provision for 22 incidental payment or indemnity under limited circumstances, for related expenses, including, but not limited to, towing, 2.3

1 "Service contract reimbursement insurance policy" means a policy of insurance that is issued to the service contract 2 3 provider to provide reimbursement to the service contract provider or to pay on behalf of the service contract provider 4 5 all covered contractual obligations incurred by the service contract provider under the terms and conditions of the insured 6 7 service contracts issued or sold by the service contract provider. 8

9 "System" means the heating, cooling, plumbing, electrical, 10 ventilation, or any other similar system of a home.
