1 AMENDMENT TO HOUSE BILL 1817

2 AMENDMENT NO. _____. Amend House Bill 1817 by replacing
3 everything after the enacting clause with the following:

4 "Section 5. The State Finance Act is amended by adding
5 Section 5.826 as follows:

6 (30 ILCS 105/5.826 new)

7 Sec. 5.826. The Illinois Police Benevolent and Protective
8 Association Fund.

9 Section 10. The Illinois Vehicle Code is amended by adding
10 Section 3-699 as follows:

11 (625 ILCS 5/3-699 new)

12 Sec. 3-699. Illinois Police Benevolent and Protective
13 Association license plates

14 (a) The Secretary, upon receipt of an application made in

1 the form prescribed by the Secretary, may issue special
2 registration plates designated as Illinois Police Benevolent
3 and Protective Association license plates. The special plates
4 issued under this Section shall be affixed only to passenger
5 vehicles of the first division and motor vehicles of the second
6 division weighing not more than 8,000 pounds. Plates issued
7 under this Section shall expire according to the multi-year
8 procedure established by Section 3-414.1 of this Code.

9 (b) The design and color of the plates is wholly within the
10 discretion of the Secretary. The Secretary may allow the plates
11 to be issued as vanity plates or personalized under Section
12 3-405.1 of the Code. The Secretary shall prescribe stickers or
13 decals as provided under Section 3-412 of this Code. The
14 Secretary may, in his or her discretion, allow the plates to be
15 issued as vanity or personalized plates in accordance with
16 Section 3-405.1 of this Code.

17 (c) An applicant for the special plate shall be charged a
18 \$25 fee for original issuance in addition to the appropriate
19 registration fee. Of this fee, \$10 shall be deposited into the
20 Illinois Police Benevolent and Protective Association Fund and
21 \$15 shall be deposited into the Secretary of State Special
22 License Plate Fund, to be used by the Secretary to help defray
23 the administrative processing costs.

24 For each registration renewal period, a \$25 fee, in
25 addition to the appropriate registration fee, shall be charged.
26 Of this fee, \$23 shall be deposited into the Illinois Police

1 Benevolent and Protective Association Fund and \$2 shall be
2 deposited into the Secretary of State Special License Plate
3 Fund.

4 (d) The Illinois Police Benevolent and Protective
5 Association Fund is created as a special fund in the State
6 treasury. All money in the Illinois Police Benevolent and
7 Protective Association Fund shall be paid, subject to
8 appropriation by the General Assembly and distribution by the
9 Secretary, as grants to the Illinois Police Benevolent and
10 Protective Association for the purposes of providing death
11 benefits for the families of police officers killed in the line
12 of duty, providing scholarships for undergraduate study to
13 children and spouses of police officers killed in the line of
14 duty, and educating the public and police officers regarding
15 policing and public safety."
