AN ACT concerning public employee benefits.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Illinois Pension Code is amended by changing
Sections 17-106 and 17-132 as follows:

6 (40 ILCS 5/17-106) (from Ch. 108 1/2, par. 17-106)

7 Sec. 17-106. Contributor, member or teacher. "Contributor", "member" or "teacher": All members of the 8 9 teaching force of the city, including principals, assistant principals, the general superintendent of schools, deputy 10 superintendents of schools, associate superintendents of 11 schools, assistant and district superintendents of schools, 12 members of the Board of Examiners, all other persons whose 13 14 employment requires a teaching certificate issued under the laws governing the certification of teachers, any educational, 15 administrative, professional, or other staff employed in a 16 17 charter school operating in compliance with the Charter Schools Law who is certified under the law governing the certification 18 of teachers, and employees of the Board, but excluding persons 19 20 contributing concurrently to any other public employee pension 21 system in Illinois for the same employment or receiving 22 retirement pensions under another Article of this Code for that same employment, persons employed on an hourly basis (provided 23

that an Employer may not reclassify a non-hourly employee as an hourly employee for the purpose of evading or avoiding its obligations under this Article), and persons receiving pensions from the Fund who are employed temporarily by an Employer and not on an annual basis.

6 All teachers or staff regardless of their position shall presumptively be participants in the Fund, unless the Employer 7 establishes to the satisfaction of the Board that an individual 8 9 certified teacher or staff member is not working as a teacher or administrator directly or indirectly with the Charter 10 11 School. Any certified teacher or staff employed by a corporate 12 or non-profit entity engaged in the administration of a charter 13 school shall presumptively be a participant in the Fund, unless 14 the organization establishes to the satisfaction of the Board that an individual certified teacher or staff member is not 15 working as a teacher or <u>administrator directly or indirectly</u> 16 17 with the Charter School.

In the case of a person who has been making contributions 18 19 and otherwise participating in this Fund prior to the effective 20 date of this amendatory Act of the 91st General Assembly, and whose right to participate in the Fund is established or 21 22 confirmed by this amendatory Act, such prior participation in 23 the Fund, including all contributions previously made and service credits previously earned by the person, are hereby 24 25 validated.

8 Sec. 17-132. Payments and certification of salary9 deductions.

10 (a) An Employer shall cause the Fund to receive all 11 members' payroll records and pension contributions within 30 12 calendar days after each predesignated payday. For purposes of 13 this Section, the predesignated payday shall be determined in 14 accordance with each Employer's payroll schedule for 15 contributions to the Fund.

16 (b) <u>An Employer that fails to timely certify and submit</u> 17 payroll records to the Fund is subject to a statutory penalty 18 <u>in the amount of \$100 per day for each day that a required</u> 19 <u>certification and submission is late.</u>

Amounts not received by the 30th calendar day after the predesignated payday shall be deemed delinquent and subject to <u>a late interest</u> penalty <u>consisting of interest</u>, <u>which shall</u> <u>accrue on a monthly basis at the Fund's then effective</u> <u>actuarial rate of return</u>, <u>and liquidated damages in the amount</u> <u>of \$100 per day</u>, <u>not to exceed 20% of the principal</u> HB2583 Engrossed - 4 - LRB098 07987 EFG 38077 b

1 <u>contributions due, which shall be mandatory except for good</u>
2 <u>cause shown and in the discretion of the Board</u> (calculated at
3 the average short-term rate of interest earned by the Fund for
4 the calendar month preceding the calendar month in which the
5 delinquency occurs) starting from the predesignated payday and
6 ending on the date payment is received.

An Employer in possession of member contributions deducted
from payroll checks is holding Fund assets, and thus becomes a
fiduciary over those assets.

10 (c) The payroll records shall report (1) all pensionable salary earned in that pay period, exclusive of salaries for 11 12 overtime, special services, or any employment on an optional basis, such as in summer school; (2) adjustments to pensionable 13 salary, exclusive of salaries for overtime, special services, 14 or any employment on an optional basis, such as in summer 15 16 school, made in a pay period for any prior pay periods; (3) 17 pension contributions attributable to pensionable salary earned in the reported pay period or the adjusted pay period as 18 required by subsection (b) of Section 17-131. 19

(d) The appropriate officers of the Employer shall certify and submit the payroll records no later than 30 calendar days after each predesignated payday. The certification shall constitute a confirmation of the accuracy of such deductions according to the provisions of this Article.

Each Charter School shall designate an administrator as a
 "Pension Officer". The Pension Officer shall be responsible for

(e) The Board has the authority to conduct payroll audits 4 5 of a charter school to determine the existence of any delinguencies in contributions to the Fund, and such charter 6 7 school shall be required to provide such books and records and contribution information as the Board or its authorized 8 9 representative may require. The Board is also authorized to 10 collect delinquent contributions from charter schools and 11 develop procedures for the collection of such delinquencies. 12 Collection procedures may include legal proceedings in the 13 courts of the State of Illinois. Expenses, including reasonable attorneys' fees, incurred in the collection of delinquent 14 15 contributions may be assessed by the Board against the charter 16 school.


