## SYNOPSIS AS INTRODUCED:

10 ILCS 5/1A-16.5 new

Amends the Election Code. Requires the State Board of Elections to establish and maintain a system for online voter registration, which will allow applicants to register to vote and to change their existing registration.

# 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

- Section 5. The Election Code is amended by changing Section
  1A-16.5 as follows:
- 6 (10 ILCS 5/1A-16.5 new)
- 7 <u>Sec. 1A-16.5. Online registration.</u>

The State Board of Elections shall establish and 8 (a) 9 maintain a system for online voter registration. Such system 10 shall also permit a registered elector to apply for changes to such elector's existing registration. An applicant may 11 12 register to vote through this system, provided the applicant's (1) registration information is verifiable in the manner 13 14 described in subsection (b) of this Section, and (2) signature is in a database described in said subsection (b) and such 15 16 signature may be imported into such system for online voter 17 registration.

(b) A State agency, upon the request of the State Board of Elections, shall provide any information, if available, to the Board that the Board deems necessary to maintain the system for online voter registration. The Board may cross reference the information input into the system by applicants with data or information contained in any State agency's database or a

1	database administered by the federal government, or any voter
2	registration database of another state, in order to verify the
3	information submitted by applicants. The Board shall not use
4	the information obtained from any such database except to
5	verify information submitted by the applicant, provided the
6	applicant's signature, if part of data contained in the State
7	agency's database, shall be included as part of the applicant's
8	information contained in the system for online voter
9	registration.

12	application, except that a signature may be obtained from
13	another State agency's database pursuant to subsection (b) of
