#### SYNOPSIS AS INTRODUCED:

30 ILCS 105/5.826 new  
625 ILCS 5/3-699 new

Amends the State Finance Act and Illinois Vehicle Code to provide for the issuance of Illinois State Police Memorial Park license plates. Creates the Illinois State Police Memorial Park Fund as a special fund in the State treasury. Provides that the applicant shall pay an additional fee of \$25 for original issuance of the plates, of which \$10 shall be deposited into the Illinois State Police Memorial Park Fund and \$15 shall be deposited into the Secretary of State Special License Plate Fund. Provides that an additional fee of \$25 shall be charged for each renewal, of which \$23 shall be deposited into the Illinois State Police Memorial Park Fund and \$2 shall be deposited into the Secretary of State Special License Plate Fund. Provides that money in the State Police Memorial Park Fund shall be paid as grants to the Illinois State Police Heritage Foundation, Inc. for specified purposes. Effective immediately.

1 AN ACT concerning transportation.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The State Finance Act is amended by adding  
5 Section 5.826 as follows:

6 (30 ILCS 105/5.826 new)

7 Sec. 5.826. The Illinois State Police Memorial Park Fund  
8 Fund.

9 Section 10. The Illinois Vehicle Code is amended by adding  
10 Section 3-699 as follows:

11 (625 ILCS 5/3-699 new)

12 Sec. 3-699. Illinois State Police Memorial Park license  
13 plates.

14 (a) The Secretary, upon receipt of an application made in  
15 the form prescribed by the Secretary of State, may issue  
16 special registration plates designated as Illinois State  
17 Police Memorial Park license plates. The special plates issued  
18 under this Section shall be affixed only to passenger vehicles  
19 of the first division or motor vehicles of the second division  
20 weighing not more than 8,000 pounds. Plates issued under this  
21 Section shall expire according to the multi-year procedure

1 established by Section 3-414.1 of this Code.

2 (b) The design and color of the plates shall be wholly  
3 within the discretion of the Secretary of State. The Secretary  
4 may, in his or her discretion, allow the plates to be issued as  
5 vanity or personalized plates in accordance with Section  
6 3-405.1 of this Code. The Secretary shall prescribe stickers or  
7 decals as provided under Section 3-412 of this Code.

8 (c) An applicant shall be charged a \$25 fee for original  
9 issuance in addition to the appropriate registration fee, if  
10 applicable. Of this fee, \$10 shall be deposited into the  
11 Illinois State Police Memorial Park Fund and \$15 shall be  
12 deposited into the Secretary of State Special License Plate  
13 Fund. For each registration renewal period, a \$25 fee, in  
14 addition to the appropriate registration fee, shall be charged.  
15 Of this fee, \$23 shall be deposited into the Illinois State  
16 Police Memorial Park Fund and \$2 shall be deposited into the  
17 Secretary of State Special License Plate Fund.

18 (d) The Illinois State Police Memorial Park Fund is created  
19 as a special fund in the State treasury. All moneys in the  
20 Illinois State Police Memorial Park Fund shall be paid, subject  
21 to appropriation by the General Assembly and distribution by  
22 the Secretary, as grants to the Illinois State Police Heritage  
23 Foundation, Inc. for building and maintaining a memorial and  
24 park, holding an annual memorial commemoration, giving  
25 scholarships to children of State police officers killed or  
26 catastrophically injured in the line of duty, and providing

1 financial assistance to police officers and their families when  
2 a police officer is killed or injured in the line of duty.

3 Section 99. Effective date. This Act takes effect upon  
4 becoming law.
