#### SYNOPSIS AS INTRODUCED:

10 ILCS 5/11-6

from Ch. 46, par. 11-6

Amends the Election Code. Requires each election authority to transmit to the principal office of the State Board of Elections maps in electronic portable document format (.PDF) showing the current boundaries of all the precincts within its jurisdiction. Further requires the county board or board of election commissioners to prepare maps in electronic portable document format (.PDF) showing election precinct boundaries that has been redivided or readjusted no later than 45 days before the next scheduled election. Sets forth requirements for forwarding these copies.

1 AN ACT concerning elections.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Election Code is amended by changing Section  
5 11-6 as follows:

6 (10 ILCS 5/11-6) (from Ch. 46, par. 11-6)

7 Sec. 11-6. Within 60 days of the effective date of this  
8 amendatory Act of 1983, each election authority shall transmit  
9 to the principal office of the State Board of Elections maps  
10 showing the current boundaries of all the precincts within its  
11 jurisdiction. Whenever election precincts in an election  
12 jurisdiction have been redivided or readjusted, the county  
13 board or board of election commissioners shall prepare maps  
14 showing such election precinct boundaries no later than 45 days  
15 before the next scheduled election. The maps, or transparent  
16 overlays, shall show the boundaries of all political  
17 subdivisions and districts. The county board or board of  
18 election commissioners shall immediately forward copies  
19 thereof to the chairman of each county central committee in the  
20 county, to each township, ward or precinct committeeman and  
21 each local election official whose political subdivision is  
22 wholly or partly in the county and, upon request, shall furnish  
23 copies thereof to each candidate for political or public office

1 in the county and shall transmit copies thereof to the  
2 principal office of the State Board of Elections.

3 Within 60 days after the effective date of this amendatory  
4 Act of the 98th General Assembly, each election authority shall  
5 transmit to the principal office of the State Board of  
6 Elections maps in electronic portable document format (.PDF)  
7 showing the current boundaries of all the precincts within its  
8 jurisdiction. Whenever election precincts in an election  
9 jurisdiction have been redivided or readjusted, the county  
10 board or board of election commissioners shall prepare maps in  
11 electronic portable document format (.PDF) showing such  
12 election precinct boundaries no later than 45 days before the  
13 next scheduled election. The maps shall show the boundaries of  
14 all political subdivisions and districts. The county board or  
15 board of election commissioners shall immediately forward  
16 copies thereof to the chairman of each county central committee  
17 in the county, to each township, ward, or precinct  
18 committeeman, and each local election official whose political  
19 subdivision is wholly or partly in the county and, upon  
20 request, shall furnish copies thereof to each candidate for  
21 political or public office in the county and shall transmit  
22 copies thereof to the principal office of the State Board of  
23 Elections.
