The amount of \$2,013,400, or so much thereof as may be necessary, is appropriated from the Illinois 6 Workers' Compensation Commission Operations Fund to Illinois 7 8 Workers' Compensation Commission for costs associated with 9 establishment, administration and operations of 10 Insurance Compliance Division of the workers' compensation program administered by 11 anti-fraud Illinois Workers' 12 Compensation Commission.
- Section 25. The amount of \$90,000, or so much thereof as
 may be necessary, is appropriated from the Illinois Workers'
 Compensation Commission Operations Fund to Illinois Workers'
 Compensation Commission for costs associated with the
 establishment of the Medical Fee Schedule and other
 provisions of the Workers' Compensation Act.
