1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named sums, or so much thereof

 7 hereinafter named:

8 Payable from General Revenue Fund:

9 For Repairs, Maintenance and

10 Other Capital Improvements .....273,300

11 Payable from the Department of Corrections

12 Reimbursement and Education Fund:

13 For payment of expenses associated

14 with School District Programs .....5,000,000

15 For payment of expenses associated

16 with federal programs, including,

17 but not limited to, construction of

18 additional beds, treatment programs,

19 and juvenile supervision .....3,000,000

20 For payment of expenses associated

21 with miscellaneous programs, including,

22 but not limited to, medical costs,

23 food expenditures, and various

24 construction costs .....5,000,000





1           Section 25. The amount of \$234,300, or so much thereof  
2           as may be necessary, is appropriated from the General Revenue  
3           Fund to the Department of Juvenile Justice for the purposes  
4           of investigating complaints, evaluating policies and  
5           procedures, and securing the rights of the youth committed to  
6           the Department of Juvenile Justice, including youth released  
7           on Aftercare before final discharge.

8           Section 99. Effective date. This Act takes effect July 1,  
9           2014.
