1 AMENDMENT TO HOUSE BILL 6145

2 AMENDMENT NO. _____. Amend House Bill 6145, by deleting
3 everything after the enacting clause and inserting the
4 following:

5 "ARTICLE 1

6 Section 1. The sum of \$1,613,800, or so much thereof as
7 may be necessary, is appropriated from the General Revenue
8 Fund to the Illinois Arts Council for operational expenses
9 for the fiscal year ending June 30, 2015.

10 Section 5. The following named sums, or so much thereof
11 as may be necessary, respectively, for the objects and
12 purposes hereinafter named, are appropriated to the Illinois
13 Arts Council to enhance the cultural environment in Illinois:

1 Payable from General Revenue Fund:

2 For Grants and Financial Assistance for

3 Creative Sector (Arts Organizations and

4 Individual Artists)4,125,800

5 For Grants and Financial Assistance for

6 Underserved Constituencies370,000

7 For Grants and Financial Assistance for

8 Arts Education582,500

9 Total \$5,078,300

10 Payable from the Illinois Arts Council

11 Federal Grant Fund:

12 For Grants and Programs to Enhance

13 the Cultural Environment855,000

14 For the purposes of Administrative

15 Costs and Awarding Grants associated with

16 the Education Leadership Institute80,000

17 Section 10. The sum of \$417,000, or so much thereof as

18 may be necessary, is appropriated from the General Revenue

19 Fund to the Illinois Arts Council for a grant to the Illinois

20 Humanities Council.

21 Section 15. The amount of \$2,012,000, or so much thereof

22 as may be necessary, is appropriated from the General Revenue

23 Fund to the Illinois Arts Council for grants to certain

1 public radio and television stations and related
2 administrative expenses, pursuant to the Public Radio and
3 Television Grant Act.

4 Section 20. In addition to other amounts appropriated
5 for this purpose, the following named sum, or so much thereof
6 as may be necessary, respectively, for the object and purpose
7 hereinafter named, is appropriated to the Illinois Arts
8 Council to enhance the cultural environment in Illinois:

9 Payable from Illinois Arts Council

10 Federal Grant Fund:

11 For Grants and Programs to Enhance

12 the Cultural Environment and associated

13 administrative costs65,000

14 Section 25. The sum of \$1,000,000, or so much thereof as
15 may be necessary, is appropriated from the General Revenue
16 Fund to the Illinois Arts Council for the purpose of funding
17 administrative and grant expenses associated with programs
18 supporting the visual arts, performing arts, languages, and
19 related activities.

20 ARTICLE 99

21 Section 99. Effective date. This Act takes effect July 1,
