1 AMENDMENT TO HOUSE BILL 6156

2 AMENDMENT NO. _____. Amend House Bill 6156, by deleting
3 everything after the enacting clause and inserting the
4 following:

5 "ARTICLE 1

6 Section 5. The sum of \$30,843,200, or so much thereof as
7 may be necessary, is appropriated from the General Revenue
8 Fund to the Office of the Attorney General to meet its
9 operational expenses for the fiscal year ending June 30,
10 2015.

11 Section 10. The sum of \$1,400,000, or so much thereof as
12 may be necessary, is appropriated from the General Revenue
13 Fund to the Office of the Attorney General for disbursement

1 to the Illinois Equal Justice Foundation for use as provided
2 in the Illinois Equal Justice Act.

3 Section 15. The sum of \$1,000,000, or so much thereof as
4 is available for use by the Attorney General, is appropriated
5 to the Attorney General from the Illinois Gaming Law
6 Enforcement Fund for State law enforcement purposes.

7 Section 20. The sum of \$10,200,000, or so much thereof
8 as may be necessary, is appropriated from the Attorney
9 General Court Ordered and Voluntary Compliance Payment
10 Projects Fund to the Office of the Attorney General for use,
11 subject to pertinent court order or agreement, in the
12 performance of any function pertaining to the exercise of the
13 duties of the Attorney General, including State law
14 enforcement and public education.

15 Section 25. The sum of \$1,900,000, or so much thereof as
16 may be necessary, is appropriated from the Illinois Charity
17 Bureau Fund to the Office of the Attorney General to enforce
18 the provisions of the Solicitation for Charity Act and to
19 gather and disseminate information about charitable trustees
20 and organizations to the public.

21 Section 30. The sum of \$7,000,000, or so much thereof as

1 may be necessary, is appropriated from the Attorney General
 2 Whistleblower Reward and Protection Fund to the Office of the
 3 Attorney General for ordinary and contingent expenses,
 4 including State law enforcement purposes.

5 Section 35. The sum of \$11,300,000, or so much thereof
 6 as may be necessary, is appropriated from the Attorney
 7 General's State Projects and Court Ordered Distribution Fund
 8 to the Attorney General for payment of interagency
 9 agreements, for court-ordered distributions to third parties,
 10 and, subject to pertinent court order, for performance of any
 11 function pertaining to the exercise of the duties of the
 12 Attorney General, including State law enforcement and public
 13 education.

14 Section 40. The following named sums, or so much thereof
 15 as may be necessary, respectively, for the objects and
 16 purposes named in this Section, are appropriated to the
 17 Attorney General to meet the ordinary and contingent expenses
 18 of the Attorney General:

14 Section 50. The sum of \$2,000,000, or so much thereof as
15 may be necessary, is appropriated from the Attorney General
16 Federal Grant Fund to the Office of the Attorney General for
17 funding for federal grants.

18 Section 55. The sum of \$500,000, or so much thereof as
19 may be necessary, is appropriated to the Office of the
20 Attorney General from the Domestic Violence Fund pursuant to
21 Public Act 95-711 for grants to public or private nonprofit
22 agencies for the purposes of facilitating or providing free

1 domestic violence legal advocacy, assistance, or services to
2 victims of domestic violence who are married or formerly
3 married or parties or former parties to a civil union related
4 to order of protection proceedings, or other proceedings for
5 civil remedies for domestic violence.

6 Section 60. The sum of \$3,500,000, or so much thereof as
7 may be necessary, is appropriated from the Attorney General
8 Tobacco Fund to the Office of the Attorney General for the
9 oversight, enforcement, and implementation of the Master
10 Settlement Agreement entered in the case of People of the
11 State of Illinois v. Philip Morris, et al (Circuit Court of
12 Cook County, No. 96L13146), for the administration and
13 enforcement of the Tobacco Product Manufacturers' Escrow Act,
14 for the handling of tobacco-related litigation, and for other
15 law enforcement activities of the Attorney General.

16 Section 65. The sum of \$50,000, or so much thereof as may
17 be necessary, is appropriated from the Attorney General Sex
18 Offender Awareness, Training, and Education Fund to the
19 Office of the Attorney General to administer the I-SORT
20 program and to alert and educate the public, victims, and
21 witnesses of their rights under various victim notification
22 laws and for training law enforcement agencies, State's
23 Attorneys, and medical providers regarding their legal duties

1 concerning the prosecution and investigation of sex offenses.

2 ARTICLE 2

ARTICLE 6

2 Section 5. The sum of \$13,091,050, or so much thereof as
3 may be necessary, respectively, is appropriated to the
4 President of the Senate and the Speaker of the House of
5 Representatives for furnishing the items provided in Section
6 4 of the General Assembly Compensation Act to members of
7 their respective houses throughout the year in connection
8 with their legislative duties and responsibilities and not in
9 connection with any political campaign as prescribed by law.
10 Of this amount, 37.436% is appropriated to the President of
11 the Senate for such expenditures and 62.564% is appropriated
12 to the Speaker of the House for such expenditures.

13 Section 10. Payments from the sums appropriated in
14 Section 5 hereof shall be made only upon the delivery of a
15 voucher approved by the member to the State Comptroller. The
16 voucher shall also be approved by the President of the Senate
17 or the Speaker of the House of Representatives as the case
18 may be.

19 Section 15. The sum of \$20,603,400, or so much thereof
20 as may be necessary, respectively, is appropriated to meet
21 the ordinary and incidental expenses of the Senate
22 legislative leadership and legislative staff assistants and

1 the House Majority and Minority leadership staff, general
2 staff and office operations. Of this amount, 25.7% is
3 appropriated to the President of the Senate for such
4 expenditures, 25.7% is appropriated to the Senate Minority
5 Leader for such expenditures and 24.8% is appropriated to the
6 Speaker of the House for such expenditures, and 23.8% is
7 appropriated to the House Minority Leader for such
8 expenditures.

9 Section 20. The sum of \$9,882,100, or so much thereof as
10 may be necessary, respectively, is appropriated to the
11 President of the Senate and the Speaker of the House of
12 Representatives for the ordinary and incidental expenses of
13 committees, the general staff and operations, per diem
14 employees, special and standing committees, expenses incurred
15 in transcribing and printing of debates. Of this amount,
16 43.018% is appropriated to the President of the Senate for
17 such expenditures and 56.982% is appropriated to the Speaker
18 of the House for such expenditures.

19 Section 25. The sum of \$309,200, or so much thereof as
