The sum of \$1,000,000, or so much thereof as 3 may be necessary and remains unexpended from an appropriation hereto made for such purposes in Section 600 of Article 12 of 4 Public Act 98-0064, is re-appropriated from the General 5 Revenue Fund to the Court of Claims for payment of awards 6 solely as a result of the lapsing of an appropriation 7 8 originally made from any funds held by the State Treasurer.
- 9 Section 25. The sum of \$7,000,000, or so much thereof as 10 may be necessary and remains unexpended from an appropriation 11 hereto made for such purposes in Section 605 of Article 12 of 12 Public Act 98-0064, is re-appropriated from the General 13 Revenue Fund to the Court of Claims for payment of line of duty awards. 14
