3 WHEREAS, Dr. Stephen Reid, Jr. has also helped plant the 4 seed to cultivate future home grown medical professionals by 5 participating in "Career Days" at East Richland Middle School; 6 and

7 WHEREAS, Dr. Stephen Reid, Jr. has lent his time and 8 expertise to many internal hospital committees to improve 9 services provided to patients, including those centered on 10 blood and tissues, ICU, long term care, patient care 11 evaluation, pharmacy, surgery, and tumors; and
