10 (c) Each organization licensee or inter-track wagering 11 licensee shall file with the Board an annual report of its 12 utilization of minority owned businesses, female owned 13 businesses, and businesses owned by persons with disabilities 14 during the preceding calendar year. The reports shall include a self-evaluation of the efforts of the organization licensee or 15 16 inter-track wagering licensee to meet its goals under this 17 Section.

(d) The organization licensee or inter-track wagering 18 licensee shall have the right to request a waiver from the 19 20 requirements of this Section. The Board shall grant the waiver where the organization licensee or inter-track wagering 21 22 licensee demonstrates that there has been made a good faith 23 effort to comply with the goals for participation by minority 24 owned businesses, female owned businesses, and businesses 25 owned by persons with disabilities.
