## 2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Coal Mining Act is amended by changing
Section 2.05 and by adding Article 40 as follows:

6 (225 ILCS 705/2.05) (from Ch. 96 1/2, par. 305)

7 Sec. 2.05. For the examination of persons seeking 8 certificates of competency as mine managers, hoisting 9 engineers, and mine examiners, the Board shall hold meetings at 10 such times and places within the State as shall, in the 11 judgment of the members, afford the best facilities to the greatest number of candidates. They shall also call an 12 examination at least once a year for electrical hoisting 13 14 engineers and at least twice a year for mine electricians.

1	evidence of at least one year of experience in performing
2	electrical work in a coal mine or acceptable related industry.
3	The applicant shall pass an examination as to his or her
4	practical and technical knowledge of the nature and properties
5	of electricity, direct and alternating currents, electrical
6	equipment and circuits, permissibility of electrical
7	equipment, the National Electrical Code, and the laws of this
8	State relating to coal mine electricity. To be eligible for
9	taking a mine electrician examination administered by the State
10	Mining Board, the applicant must meet at least one of the
11	following criteria:
12	(1) be classified as an apprentice mine electrician and
13	have met the requirements for an apprentice;
14	(2) possess a Bachelor of Science degree in electrical
15	engineering and provide evidence of experience;
16	<u>(3) possess a current coal mine electrician</u>

2	Sec. 40.2. Electrical equipment and systems; examination,
3	testing, and maintenance. All electrical equipment and systems
4	shall be frequently examined and tested and properly maintained
5	by a mine electrician to ensure safe operating conditions. When
6	a potentially dangerous condition is found in electrical
7	equipment or an electrical system, the equipment or system
8	shall be removed from service until the condition is corrected.
9	A record of the examinations shall be kept and made available
10	to the company, the State Mine Inspector, and all other persons
11	interested.
