## SYNOPSIS AS INTRODUCED:

205 ILCS 5/3

Amends the Illinois Banking Act. Makes a technical change in a Section concerning the primary powers of banks.

1 AN ACT concerning regulation.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Banking Act is amended by changing Section 3 as follows:
- 6 (205 ILCS 5/3) (from Ch. 17, par. 309)
- 7 Sec. 3. Formation and primary powers. It shall be lawful to 8 form banks, as herein provided, for the the purpose of discount 9 and deposit, buying and selling exchange and doing a general banking business, excepting the issuing of bills to circulate 10 as money; and such banks shall have the power to loan money on 11 personal and real estate security, and to accept and execute 12 13 trusts upon obtaining a certificate of authority pursuant to 14 the "Corporate Fiduciary Act", and shall be subject to all of the provisions of this Act. For purposes of this Section, "real 15 16 estate" includes a manufactured home as defined in subdivision 17 (53) of Section 9-102 of the Uniform Commercial Code that is real property as defined in Section 5-35 of the Conveyance and 18 Encumbrance of Manufactured Homes as Real Property and 19 20 Severance Act.
