- 7 State University to meet ordinary and contingent expenses
- 8 incurred through August 31, 2016.
- 9 Section 10. The amount of \$7,499,333, or so much of that
- 10 amount as may be necessary, is appropriated from the Education
- 11 Assistance Fund to the Board of Trustees of Governors State
- 12 University to meet ordinary and contingent expenses incurred
- 13 through August 31, 2016.

- 1 Section 15. The amount of \$11,500,100, or so much of that
- 2 amount as may be necessary, is appropriated from the Education
- 3 Assistance Fund to the Board of Trustees of Northeastern
- 4 Illinois University to meet ordinary and contingent expenses
- 5 incurred through August 31, 2016.
- 6 Section 20. The amount of \$61,808,833, or so much of that
- 7 amount as may be necessary, is appropriated from the Education
- 8 Assistance Fund to the Board of Trustees of Southern Illinois
- 9 University to meet ordinary and contingent expenses incurred
- 10 through August 31, 2016.
- 11 Section 25. The amount of \$181,709,100, or so much of
- 12 that amount as may be necessary, is appropriated from the
- 13 Education Assistance Fund to the Board of Trustees of the
- 14 University of Illinois to meet ordinary and contingent expenses
- 15 incurred through August 31, 2016.
- Section 30. The amount of \$13,394,067, or so much of that
- 17 amount as may be necessary, is appropriated from the Education
- 18 Assistance Fund to the Board of Trustees of Eastern Illinois
- 19 University to meet ordinary and contingent expenses incurred
- 20 through August 31, 2016.
- 21 Section 35. The sum of \$22,510,667, or so much of that

- 1 amount as may be necessary, is appropriated from the Education
- Assistance Fund to the Board of Trustees of Illinois State 2
- University to meet ordinary and contingent expenses incurred 3
- through August 31, 2016. 4
- 5 Section 40. The amount of \$28,390,567, or so much of that
- amount as may be necessary, is appropriated from the Education 6
- Assistance Fund to the Board of Trustees of Northern Illinois 7
- University to meet ordinary and contingent expenses incurred 8
- 9 through August 31, 2016.
- 10 Section 45. The amount of \$16,033,767, or so much of that
- 11 amount as may be necessary, is appropriated from the Education
- 12 Assistance Fund to the Board of Trustees of Western Illinois
- University to meet ordinary and contingent expenses incurred 13
- 14 through August 31, 2016.
- 15 Section 50. The amount of \$198,536,550, or so much of
- 16 that amount as may be necessary, is appropriated from the
- Education Assistance Fund to the Illinois Student Assistance 17
- 18 Commission for grant awards to students eligible for the
- Monetary Award Program, as provided by law, and for agency 19
- 20 administrative and operational costs for the Monetary Award
- 21 Program not to exceed 2% of the total appropriation in this
- 22 Section.

- Section 55. The amount of \$5,709,733, or so much of that 1
- amount as may be necessary, is appropriated from the Education 2
- Assistance Fund to the Illinois Mathematics and Science Academy
- to meet ordinary and contingent expenses incurred through
- August 31, 2016. 5
- 6 Section 99. Effective date. This Act takes effect upon
- 7 becoming law.".
