A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. "Operational expenses" defined. For the
6 purposes of this Act, the term "operational expenses"
7 includes the following items:

- 8 (a) Personal Services;
- 9 (b) State contributions to Social Security
- 10 (c) Group Insurances;
- 11 (d) Contractual Services
- 12 (e) Travel;
- 13 (f) Commodities;
- 14 (g) Printing;
- 15 (h) Equipment;
- 16 (i) Electronic data processing;
- 17 (j) Telecommunications services;
- 18 (k) Operation of automotive equipment;
- 19 (l) Refunds;
- 20 (m) Employee retirement contributions paid by the employer;
- 21 (n) Permanent improvements;
- 22 (o) Deposits to other funds.

1 Section 5. In addition to other amounts appropriated,
 2 the amount of \$8,087,400, or so much thereof as may be
 3 necessary, is appropriated from the General Revenue Fund to
 4 the Illinois Arts Council for operational expenses, awards,
 5 grants and permanent improvements for the fiscal year ending
 6 June 30, 2016.

7 Section 10. The following named sums, or so much thereof
 8 as may be necessary, respectively, for the objects and
 9 purposes hereinafter named, are appropriated to the Illinois
 10 Arts Council to enhance the cultural environment in Illinois:

12 Federal Grant Fund:

13 For Grants and Programs to Enhance
 14 the Cultural Environment935,000
 15 For the purposes of Administrative
 16 Costs and Awarding Grants associated with
 17 the Education Leadership Institute0

18 Section 15. In addition to other amounts appropriated
 19 for this purpose, the following named sum, or so much thereof
 20 as may be necessary, respectively, for the object and purpose
 21 hereinafter named, is appropriated to the Illinois Arts
 22 Council to enhance the cultural environment in Illinois:

2 Federal Grant Fund:
3 For Grants and Programs to Enhance
4 the Cultural Environment and associated
5 administrative costs65,000

6 Section 99. Effective date. This Act takes effect July 1,
7 2015.
