2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Nursing Home Care Act is amended by changing
Section 3-303.1 as follows:

6 (210 ILCS 45/3-303.1) (from Ch. 111 1/2, par. 4153-303.1)
7 Sec. 3-303.1. Waiver of requirements.

(a) Upon application by a facility, the Director may grant 8 9 or renew the waiver of the facility's compliance with a rule or standard for a period not to exceed the duration of the current 10 license or, in the case of an application for license renewal, 11 the duration of the renewal period. The waiver may be 12 conditioned upon the facility taking action prescribed by the 13 14 Director as a measure equivalent to compliance. In determining whether to grant or renew a waiver, the Director shall consider 15 the duration and basis for any current waiver with respect to 16 17 the same rule or standard and the validity and effect upon patient health and safety of extending it on the same basis, 18 19 the effect upon the health and safety of residents, the quality 20 of resident care, the facility's history of compliance with the 21 rules and standards of this Act and the facility's attempts to 22 comply with the particular rule or standard in question.

(b) The Department may provide, by rule, for the automatic

1 renewal of waivers concerning physical plant requirements upon 2 the renewal of a license. The Department shall renew waivers 3 relating to physical plant standards issued pursuant to this 4 Section at the time of the indicated reviews, unless it can 5 show why such waivers should not be extended for the following 6 reasons:

7 <u>(1)</u> (a) the condition of the physical plant has 8 deteriorated or its use substantially changed so that the 9 basis upon which the waiver was issued is materially 10 different; or

11 <u>(2)</u> (b) the facility is renovated or substantially 12 remodeled in such a way as to permit compliance with the 13 applicable rules and standards without substantial 14 increase in cost.

(c) Upon application by a facility, the Director may grant 15 16 or renew a waiver of the registered nurse staffing requirements 17 contained in subsection (e) of Section 3-202.05, considering the criteria in subsection (a), if the facility demonstrates to 18 19 the Director's satisfaction that the facility is unable, 20 despite diligent efforts, including offering wages at a competitive rate for registered nurses in the community, to 21 22 employ the required number of registered nurses. Waivers 23 granted under this subsection shall be reviewed quarterly by 24 the Department, including requiring a demonstration by the 25 facility that it has continued to make diligent efforts to employ the required number of registered nurses, and shall be 26

1 <u>revoked for noncompliance with any of the following</u> 2 requirements:

3 <u>(1) For periods in which the number of registered</u> 4 <u>nurses required by law is not in the facility, a physician</u> 5 <u>or registered nurse shall respond immediately to a</u> 6 telephone call from the facility.

7 (2) The facility shall notify the following of the
8 waiver: the Office of the State Long Term Care Ombudsman,
9 the residents of the facility, the residents' quardians,
10 and the residents' representatives.

11 (d) A copy of each waiver application and each waiver 12 granted or renewed shall be on file with the Department and 13 available for public inspection. The Director shall annually review such file and recommend to the Long Term Care Facility 14 15 Advisory Board any modification in rules or standards suggested 16 by the number and nature of waivers requested and granted and 17 the difficulties faced in compliance by similarly situated facilities. 18
