SYNOPSIS AS INTRODUCED:

55 ILCS 5/Div. 4-14 heading new 55 ILCS 5/4-14001 new 65 ILCS 5/10-4-13 new 820 ILCS 115/4.5 new

Amends the Counties Code. Provides that after the effective date of this amendatory Act and notwithstanding any other provision of law, employees of a county or municipality, including employees subject to collective bargaining agreements, may not carry over or transfer any more than 5 vacation days, 5 personal days, and 5 sick days accrued in one calendar to the next calendar year. Amends the Illinois Municipal Code and the Illinois Wage Payment and Collection Act with the same changes. Effective immediately.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 17 Section 10. The Illinois Municipal Code is amended by
- 18 adding Section 10-4-13 as follows:

- 20 Sec. 10-4-13. Vacation, personal, and sick day carry-over.

- 4 to collective bargaining agreements, may not carry over or
- 5 transfer any more than 5 vacation days, 5 personal days, and 5

- 7 Section 15. The Illinois Wage Payment and Collection Act is
- 8 amended by adding Section 4.5 as follows:
- 9 (820 ILCS 115/4.5 new)
- Sec. 4.5. Vacation, personal, and sick day carry-over of
- 11 county and municipal employees. After the effective date of
- 12 this amendatory Act of the 99th General Assembly and
- 13 notwithstanding any other provision of law, employees of a
- 14 county or municipality, including employees subject to
- 15 collective bargaining agreements, may not carry over or
- transfer any more than 5 vacation days, 5 personal days, and 5
- 17 sick days accrued in one calendar to the next calendar year.
- 18 Section 99. Effective date. This Act takes effect upon
- 19 becoming law.
