

1 AN ACT making appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much  
6 thereof as may be necessary, respectively, for the objects

23 Section 60. The sum of \$750,000, or so much thereof as  
 24 may be necessary, is appropriated from the Radiation

1 Protection Fund to the Illinois Emergency Management Agency  
2 for licensing facilities where radioactive uranium and  
3 thorium mill tailings are generated or located, and related  
4 costs for regulating the decontamination and decommissioning  
5 of such facilities and for identification, decontamination  
6 and environmental monitoring of unlicensed properties  
7 contaminated with such radioactive mill tailings.

8 Section 65. The sum of \$20,000, or so much thereof as  
9 may be necessary, is appropriated from the Radiation  
10 Protection Fund to the Illinois Emergency Management Agency  
11 for the purpose of funding costs related to environmental  
12 cleanup of the Ottawa Radiation Areas Superfund Project under  
13 cooperative agreements with the Federal Government.

14 Section 70. The sum of \$100,000, or so much thereof as  
15 may be necessary, is appropriated from the Radiation  
16 Protection Fund to the Illinois Emergency Management Agency  
17 for recovery and remediation of radioactive materials and  
18 contaminated facilities or properties when such expenses  
19 cannot be paid by a responsible person or an available  
20 surety.

21 Section 75. The sum of \$65,000, or so much thereof as  
22 may be necessary, is appropriated from the Radiation

1 Protection Fund to the Illinois Emergency Management Agency  
2 for local responder training, demonstrations, research,  
3 studies and investigations under funding agreements with the  
4 Federal Government.

5 Section 80. The sum of \$57,000, or so much thereof as  
6 may be necessary, is appropriated from the Nuclear Safety  
7 Emergency Preparedness Fund to the Illinois Emergency  
8 Management Agency for related training and travel expenses  
9 and to reimburse the Illinois State Police and the Illinois  
10 Commerce Commission for costs incurred for activities related  
11 to inspecting and escorting shipments of spent nuclear fuel,  
12 high-level radioactive waste, and transuranic waste in  
13 Illinois as provided under the rules of the Agency.

14 Section 85. The sum of \$271,200, or so much thereof as  
15 may be necessary, is appropriated from the Sheffield Agreed  
16 Order Fund to the Illinois Emergency Management Agency for  
17 the care, maintenance, monitoring, testing, remediation and  
18 insurance of the low-level radioactive waste disposal site  
19 near Sheffield, Illinois.

20 Section 90. The sum of \$990,000, or so much thereof as  
21 may be necessary, is appropriated from the Low-Level  
22 Radioactive Waste Facility Development and Operation Fund to

1 the Illinois Emergency Management Agency for use in  
2 accordance with Section 14(a) of the Illinois Low-Level  
3 Radioactive Waste Management Act for costs related to  
4 establishing a low-level radioactive waste disposal facility.

5 Section 95. The sum of \$240,000, or so much thereof as  
6 may be necessary, is appropriated from the Nuclear Safety  
7 Emergency Preparedness Fund to the Illinois Emergency  
8 Management Agency for ordinary and contingent expenses of the  
9 Illinois Emergency Management Agency to include support of a  
10 centralized administrative processing center.

11 ARTICLE 999

12 Section 999. Effective date. This Act takes effect July 1,  
13 2015.
