The Humane Care for Animals Act is amended by 4 5 changing Section 3.01 as follows: 6 (510 ILCS 70/3.01) (from Ch. 8, par. 703.01) 7 Sec. 3.01. Cruel treatment. (a) No person or owner may beat, cruelly treat, torment, 8 starve, overwork or otherwise abuse any animal. 10 (b) No owner may abandon any animal where it may become a public charge or may suffer injury, hunger or exposure. 11 12 (c) No owner of a dog or cat that is a companion animal may 13 expose the dog or cat in a manner that places the dog or cat in a life-threatening situation for a prolonged period of time in 14

(1) results in injury to or death of the animal; or

extreme heat or cold conditions that:

(2) results in hypothermia, hyperthermia, frostbite, 1 or similar condition. 2

- (d) (c) A person convicted of violating this Section is 3 4 quilty of a Class A misdemeanor. A second or subsequent 5 conviction for a violation of this Section is a Class 4 felony. In addition to any other penalty provided by law, a person who 6 is convicted of violating subsection (a) upon a companion 7 animal in the presence of a child, as defined in Section 12-0.1 8 9 of the Criminal Code of 2012, shall be subject to a fine of 10 \$250 and ordered to perform community service for not less than 11 100 hours. In addition to any other penalty provided by law, upon conviction for violating this Section, the court may order 12 the convicted person to undergo a psychological or psychiatric 13 14 evaluation and to undergo any treatment at the convicted 15 person's expense that the court determines to be appropriate 16 after due consideration of the evidence. If the convicted person is a juvenile or a companion animal hoarder, the court 17 18 must order the convicted person to undergo a psychological or psychiatric evaluation and to undergo treatment that the court 19 20 determines to be appropriate after due consideration of the evaluation. 2.1
