1 AMENDMENT TO HOUSE BILL 5161 2 AMENDMENT NO. . Amend House Bill 5161 by replacing everything after the enacting clause with the following: 3 "Section 5. The Use Tax Act is amended by changing Section 4 3-5 as follows: 5 6 (35 ILCS 105/3-5)7 Sec. 3-5. Exemptions. Use of the following tangible 8 personal property is exempt from the tax imposed by this Act: (1) Personal property purchased from a corporation, 9 10 society, association, foundation, institution, organization, other than a limited liability company, that is 11 12 organized and operated as a not-for-profit service enterprise 13 for the benefit of persons 65 years of age or older if the personal property was not purchased by the enterprise for the 14 15 purpose of resale by the enterprise.

- 1 (10) A motor vehicle that is used for automobile renting, as defined in the Automobile Renting Occupation and Use Tax 2 Act. 3
- (11) Farm machinery and equipment, both new and used, including that manufactured on special order, certified by the purchaser to be used primarily for production agriculture or State or federal agricultural programs, including individual 7 replacement parts for the machinery and equipment, including machinery and equipment purchased for lease, and including implements of husbandry defined in Section 1-130 of the Illinois Vehicle Code, farm machinery and agricultural chemical and fertilizer spreaders, and nurse wagons required to be registered under Section 3-809 of the Illinois Vehicle Code, but excluding other motor vehicles required to be registered under the Illinois Vehicle Code. Horticultural polyhouses or hoop houses used for propagating, growing, or overwintering plants shall be considered farm machinery and equipment under 17 this item (11). Farm machinery and equipment shall include precision farming equipment that is installed or purchased to be installed on farm machinery and equipment including, but not limited to, tractors, harvesters, sprayers, planters, seeders,

- or spreaders. Precision farming equipment includes, but is not
- 2 limited to, soil testing sensors, computers, monitors,
- 3 software, global positioning and mapping systems, and other
- 4 such equipment.
- 5 Farm machinery and equipment also includes computers,
- 6 sensors, software, and related equipment used primarily in the

- 8 facilities, equipment, and activities such as, but not limited

(22) Computers and communications equipment utilized for any hospital purpose and equipment used in the diagnosis, analysis, or treatment of hospital patients purchased by a lessor who leases the equipment, under a lease of one year or longer executed or in effect at the time the lessor would otherwise be subject to the tax imposed by this Act, to a hospital that has been issued an active tax exemption identification number by the Department under Section 1g of the Retailers' Occupation Tax Act. If the equipment is leased in a manner that does not qualify for this exemption or is used in any other non-exempt manner, the lessor shall be liable for the tax imposed under this Act or the Service Use Tax Act, as the case may be, based on the fair market value of the property at the time the non-qualifying use occurs. No lessor shall collect or attempt to collect an amount (however designated) that purports to reimburse that lessor for the tax imposed by this Act or the Service Use Tax Act, as the case may be, if the tax has not been paid by the lessor. For purposes of this exemption, "a corporation, limited liability company, society, association, foundation, institution organized and operated exclusively educational purposes" means all tax-supported public schools, private schools that offer systematic instruction in useful branches of learning by methods common to public schools and that compare favorably in their scope and intensity with the course of study presented in tax-supported schools, vocational or technical schools or institutes organized and operated exclusively to provide a course of study of not less than 6 weeks duration and designed to prepare individuals to follow a trade or to pursue a manual, technical, mechanical, industrial, business, or commercial occupation.
