1 AMENDMENT TO HOUSE BILL 5681 2 AMENDMENT NO. . Amend House Bill 5681 by replacing everything after the enacting clause with the following: 3 "Section 5. The Illinois Pension Code is amended by 4 5 changing Section 17-142.1 as follows: 6 (40 ILCS 5/17-142.1) (from Ch. 108 1/2, par. 17-142.1) 7 Sec. 17-142.1. To defray health insurance costs. To provide 8 for the partial reimbursement of health insurance costs. (1) On the first day of September of each year, beginning 9 in 1988, the Board may, by separate warrant, pay to each 10 recipient of a service retirement, disability retirement or 11 12 survivor's pension an amount to be determined by the Board, 13 which shall represent partial reimbursement for the cost of the recipient's health insurance coverage. 14 15 (2) In lieu of the annual payment authorized in subdivision

(1), for pensioners enrolled in the Fund's regular health care

| 1 | deduction plans, the Fund may pay the health insurance premium  |

| 5 | form of a direct payment of premium and a reduction in the      |

- (3) Total payments under this Section in any year may not exceed \$65,000,000 plus any amount that was authorized to be paid under this Section in the preceding year but was not actually paid by the Board, including any interest earned thereon.
- (4) The total amount of payments under this Section in any year may not exceed 75% of the total cost of health insurance coverage in that year for all the recipients who receive payments authorized by this Section in that year.
- (5) There is hereby created the Chicago Teachers' Pension
  Fund Health Insurance Task Force. The Task Force shall consist
  of 12 members appointed as follows:
- 20 <u>(a) Eight members, 2 of whom shall be appointed by each</u>
  21 of the 4 legislative leaders.
- (b) One member, who shall be appointed by the board of trustees of the Fund.
- 24 <u>(c) One member, who shall be appointed by an</u>
  25 organization that represents retired Chicago teachers.
- 26 (d) One member, who shall be appointed by an

| 4  | The Task force shall study and consider the program of          |
| 5  | health insurance coverage for pensioners that is currently      |
| 6  | administered by the Fund, and shall present its findings and    |
| 7  | recommendations concerning the following specified matters:     |
| 8  | (i) the need for increasing the \$65,000,000 limitation         |
| 9  | on annual payments under subsection (3) of this Section;        |
| 10 | (ii) moving the administration of the retiree health            |
| 11 | plan to another appropriate public or private entity;           |
| 12 | (iii) suggestions for an exit strategy and transition;          |
| 13 | (iv) consideration of alternative funding mechanisms;           |

| 17 | Members of the Task Force shall serve without compensation.     |

| 20 | The Task Force shall present a final report of its findings     |
| 21 | and recommendations to the Governor of Illinois, the Mayor of   |
| 22 | Chicago, the Illinois General Assembly, and the Illinois State  |
| 23 | Library no later than January 31, 2017. Upon the filing of its  |
| 24 | report and the conclusion of its business, the Task Force is    |
| 25 | abolished.  |
