Amends the Co-operative Act. Provides that a cooperative may be organized for the purpose of the shareholders operating a business without qualification regarding the type of business. Effective immediately.

1 AN ACT concerning business.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The Co-operative Act is amended by changing Section 1 as follows:

6 (805 ILCS 310/1) (from Ch. 32, par. 305)

Sec. 1. Any 5 or more subscribers to the shares of the capital stock of a corporation to be organized under this Act who may be desirous of uniting as mechanics, laborers, agriculturists, or in any other capacity in any co-operative association for the purpose of purchasing of or selling to all shareholders and others, all sorts of groceries, provisions and any other articles of merchandise, for cash or otherwise at wholesale or retail, at such reasonable prices over the cost thereof as will enable the members of such association to obtain or dispose of such commodities at the smallest practicable rate of cost and also, if desired, to manufacture any articles of trade or merchandise such as flour, meal, boots, shoes, clothing, groceries and to sell same as above stated, or for the purpose of cultivating and raising vegetables, fruits or other products, or animals for food for said members or to sell same as above stated, or who may be desirous of engaging as shareholders in any association for the

1 conducting of а general agricultural 2 horticultural business by such shareholders, combination of the 2 for the purpose of growing or producing 3 general or special agricultural, horticultural, orchard, 4 5 garden, nursery or dairy produce, or for the manufacture and 6 sale, or the sale, or the purchasing of, or the dealing in any 7 of the commodities mentioned in this section either wholesale or retail, either for the use of such shareholders or 8 9 for sale to other persons, or who may be desirous of becoming 10 interested in other like associations -- may become incorporated 11 for that purpose by making a statement to that effect under 12 their signatures and duly acknowledged before an officer 13 authorized to take acknowledgments, setting forth: (a) the name of the corporation; (b) the address, including street and 14 15 number, if any, of its initial registered office in this State, 16 and the name of its initial registered agent at such address; 17 (c) the period of duration, which may be perpetual; (d) the name and address, including street and number, if any, of each 18 19 incorporator; (e) the purpose or purposes for which the 20 corporation is organized; (f) the aggregate number of shares which the corporation shall have authority to issue; and if the 21 22 shares are to consist of one class only, the par value of each 23 of the shares; or, if the shares are to be divided into classes, the number of shares of each class, if any, that are 24 25 to have a par value of each share of each such class, and the number of shares of each class, if any, that are to be without 26

par value; (q) if the shares are to be divided into classes, 1 2 the designation of each class and a statement of 3 preferences, qualifications, limitations, restrictions, the special or relative rights in respect of the shares of each 5 class; (h) the number and class of shares to be issued by the it 6 corporation before commences business, and 7 consideration to be received by the corporation therefor, which shall be not less than \$1,000. If shares of more than one class 8 9 are to be issued, the consideration for shares of each class 10 shall be separately stated; (i) the number of directors to be 11 elected at the first meeting of shareholders; (j) any 12 provisions, not inconsistent with law, which the incorporators 13 may choose to insert, for the regulation of the internal 14 affairs of the corporation.
