SYNOPSIS AS INTRODUCED:

30 ILCS 105/5.875 new 625 ILCS 5/3-699.14

Amends the State Finance Act. Creates the Order of the Eastern Star Fund as a special fund in the State treasury. Amends the Illinois Vehicle Code to allow for the issuance of decals by the Order of the Eastern Star. Provides for the original and renewal fees and fee distribution for Universal special license plates with decals issued by the Order of the Eastern Star.

A BILL FOR

1 AN ACT concerning transportation.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 Section 5. The State Finance Act is amended by adding 5 Section 5.875 as follows:

7 <u>Sec. 5.875. The Order of the Eastern Star Fund.</u>

8 Section 10. The Illinois Vehicle Code is amended by 9 changing Section 3-699.14 as follows:

13 Sec. 3-699.14. Universal special license plates.

14 (a) In addition to any other special license plate, the Secretary, upon receipt of all applicable fees and applications 15 made in the form prescribed by the Secretary, may issue 16 17 Universal special license plates to residents of Illinois on behalf of organizations that have been authorized by the 18 19 General Assembly to issue decals for Universal special license 20 plates. Appropriate documentation, as determined by the Secretary, shall accompany each application. Authorized 21

1 organizations shall be designated by amendment to this Section. 2 When applying for a Universal special license plate the 3 applicant shall inform the Secretary of the name of the authorized organization from which the applicant will obtain a 4 5 decal to place on the plate. The Secretary shall make a record of that organization and that organization shall remain 6 affiliated with that plate until the plate is surrendered, 7 8 revoked, or otherwise cancelled. The authorized organization 9 may charge a fee to offset the cost of producing and 10 distributing the decal, but that fee shall be retained by the 11 authorized organization and shall be separate and distinct from 12 any registration fees charged by the Secretary. No decal, 13 sticker, or other material may be affixed to a Universal special license plate other than a decal authorized by the 14 15 General Assembly in this Section or a registration renewal 16 sticker. The special plates issued under this Section shall be 17 affixed only to passenger vehicles of the first division, including motorcycles and autocycles, or motor vehicles of the 18 second division weighing not more than 8,000 pounds. Plates 19 20 issued under this Section shall expire according to the multi-year procedure under Section 3-414.1 of this Code. 21

(b) The design, color, and format of the Universal special license plate shall be wholly within the discretion of the Secretary. Universal special license plates are not required to designate "Land of Lincoln", as prescribed in subsection (b) of Section 3-412 of this Code. The design shall allow for the

application of a decal to the plate. Organizations authorized 1 2 by the General Assembly to issue decals for Universal special 3 license plates shall comply with rules adopted by the Secretary governing the requirements for and approval of Universal 4 5 special license plate decals. The Secretary may, in his or her discretion, allow Universal special license plates to be issued 6 7 as vanity or personalized plates in accordance with Section 8 3-405.1 of this Code. The Secretary of State must make a 9 version of the special registration plates authorized under 10 this Section in a form appropriate for motorcycles and 11 autocycles.

12 (c) When authorizing a Universal special license plate, the 13 General Assembly shall set forth whether an additional fee is to be charged for the plate and, if a fee is to be charged, the 14 15 amount of the fee and how the fee is to be distributed. When 16 necessary, the authorizing language shall create a special fund 17 in the State treasury into which fees may be deposited for an authorized Universal special license plate. Additional fees 18 may only be charged if the fee is to be paid over to a State 19 20 agency or to a charitable entity that is in compliance with the registration and reporting requirements of the Charitable 21 22 Trust Act and the Solicitation for Charity Act. Any charitable 23 entity receiving fees for the sale of Universal special license plates shall annually provide the Secretary of State a letter 24 25 of compliance issued by the Attorney General verifying that the 26 entity is in compliance with the Charitable Trust Act and the

1 Solicitation for Charity Act.

2 Upon original issuance and for each registration (d) 3 renewal period, in addition to the appropriate registration fee, if applicable, the Secretary shall collect any additional 4 5 fees, if required, for issuance of Universal special license plates. The fees shall be collected on behalf of the 6 organization designated by the applicant when applying for the 7 plate. All fees collected shall be transferred to the State 8 9 agency on whose behalf the fees were collected, or paid into 10 the special fund designated in the law authorizing the 11 organization to issue decals for Universal special license 12 plates. All money in the designated fund shall be distributed 13 by the Secretary subject to appropriation by the General 14 Assembly.

(e) The following organizations may issue decals for
 Universal special license plates with the original and renewal
 fees and fee distribution as follows:

(1) The Order of the Eastern Star.

19(A) Original issuance: \$25; with \$10 to the Order20of the Eastern Star Fund and \$15 to the Secretary of21State Special Plate Fund.

22 <u>(B) Renewal: \$25; with \$23 to the Order of the</u> 23 <u>Eastern Star Fund and \$2 to the Secretary of State</u> 24 <u>Special Plate Fund.</u>
