A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The sum of \$1,504,400, or so much thereof as
6 may be necessary, is appropriated from the General Revenue
7 Fund to the Illinois Arts Council for operational expenses
8 for the fiscal year ending June 30, 2017.

9 Section 5. The following named sums, or so much thereof
10 as may be necessary, respectively, for the objects and
11 purposes hereinafter named, are appropriated to the Illinois
12 Arts Council to enhance the cultural environment in Illinois:

13 Payable from General Revenue Fund:

14	For Grants and Financial Assistance for	
15	Creative Sector (Arts Organizations and	
16	Individual Artists)	4,124,800
17	For Grants and Financial Assistance for	
18	Underserved Constituencies	370,000
19	For Grants and Financial Assistance for	
20	Arts Education	<u>582,500</u>
21	Total	\$5,077,300

1 Payable from the Illinois Arts Council
 2 Federal Grant Fund:
 3 For Grants and Programs to Enhance
 4 the Cultural Environment935,000

5 Section 10. The sum of \$1,000,000, or so much thereof as
 6 may be necessary, is appropriated from the General Revenue
 7 Fund to the Illinois Arts Council for the purpose of funding
 8 administrative and grant expenses associated with programs
 9 supporting the visual arts, performing arts, languages and
 10 related activities.

11 Section 15. The amount of \$2,012,000, or so much thereof
 12 as may be necessary, is appropriated from the General Revenue
 13 Fund to the Illinois Arts Council for grants to certain
 14 public radio and television stations and related
 15 administrative expenses, pursuant to the Public Radio and
 16 Television Grant Act.

17 Section 20. In addition to other amounts appropriated
 18 for this purpose, the following named sum, or so much thereof
 19 as may be necessary, respectively, for the object and purpose
 20 hereinafter named, is appropriated to the Illinois Arts
 21 Council to enhance the cultural environment in Illinois:

22 Payable from Illinois Arts Council

1 Federal Grant Fund:
 2 For Grants and Programs to Enhance
 3 the Cultural Environment and associated
 4 administrative costs65,000

5 Section 25. The sum of \$417,000, for so much thereof as
 6 may be necessary, is appropriated for a grant from the
 7 Illinois Arts Council to the Illinois Humanities Council.

8 Section 99. Effective Date. This Act takes effect July
 9 1, 2016, if and only if Senate Bill 2789 of the 99th General
 10 Assembly (the Unbalanced Budget Response Act), as introduced
 11 in the Illinois Senate, becomes law.
