## HOUSE JOINT RESOLUTION

2 WHEREAS, It is highly fitting that the Illinois General 3 Assembly pays honor and respect to the truly great individuals 4 who have served our country; and

5 WHEREAS, Staff Sergeant Paul Smith died in the service of 6 his country in Kandahar, Afghanistan, in the summer of 2009; 7 and

8 WHEREAS, Staff Sergeant Smith retired from the United 9 States Army in 2006 after tours in Kuwait, Bosnia, Iraq, and 10 Afghanistan, but he did not retire from combat; and

WHEREAS, Staff Sergeant Smith joined the Illinois National
 Guard with the 33rd Infantry Brigade Combat Team; and

13 WHEREAS, Staff Sergeant Smith's 2009 deployment was his 14 third in Afghanistan with Troop C, 2nd Battalion, 106th Cavalry 15 Regiment, providing protection for Embedded Training Teams and 16 the Afghan army; and

WHEREAS, In late August of 2009, at the age of 43, Staff Sergeant Smith volunteered for a mission, manning the gunner position atop a Humvee, fifth in a military convoy; and HJ0120 Engrossed -2- LRB099 16690 MST 41029 r
WHEREAS, Staff Sergeant Smith typically rode in the first
or last vehicle in the line; he was killed instantly when an
improvised explosive device detonated near his vehicle;
another soldier was killed and 2 were seriously injured in the
explosion; and

6 WHEREAS, The device was the first of its kind to be 7 floating in a roadside canal, and not on the side of the road 8 like all the others that had caused so much death and injury in 9 the war in Afghanistan; and

10 WHEREAS, A small home on Jay Street in East Peoria 11 currently holds a beautiful tribute to Staff Sergeant Smith, 12 including photos, a quilt, and a framed sketch by an artist who 13 has done the same for every 2,350 American fatalities in the 14 war in Afghanistan to date; and

15 WHEREAS, Staff Sergeant Smith's dedication, heroism, and 16 courage will never be forgotten by his family, city, State, and 17 country; therefore, be it

18 RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE 19 NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE 20 SENATE CONCURRING HEREIN, that we designate the section of 21 Illinois Route 8 in East Peoria beginning at the intersection 22 of Arnold Avenue and ending at the intersection of Oakwood Road HJ0120 Engrossed -3- LRB099 16690 MST 41029 r as the "Staff Sergeant Paul Smith Memorial Highway"; and be it further

3 RESOLVED, That the Illinois Department of Transportation 4 is requested to erect, at suitable locations consistent with 5 State and federal regulations, an appropriate plaque or signs 6 giving notice of the name of the "Staff Sergeant Paul Smith 7 Memorial Highway"; and be it further

8 RESOLVED, That suitable copies of this resolution be 9 presented to the family of Staff Sergeant Smith, the Mayor of 10 East Peoria, and the Secretary of the Illinois Department of 11 Transportation.
