No alcoholic liquors shall be sold or delivered 8 in any building belonging to or under the control of the State 9 or any political subdivision thereof except as provided in this corporate authorities of any city, village, 10 Act. The incorporated town, township, or county may provide by 11 ordinance, however, that alcoholic liquor may be sold or 12 delivered in any specifically designated building belonging to 13 14 or under the control of the municipality, township, or county, or in any building located on land under the control of the 15 16 municipality, township, or county; provided that such township or county complies with all applicable local ordinances in any 17 incorporated area of the township or county. Alcoholic liquor 18 19 may be delivered to and sold under the authority of a special use permit on any property owned by a conservation district 20 21 organized under the Conservation District Act, provided that 22 (i) the alcoholic liquor is sold only at an event authorized by the governing board of the conservation district, (ii) the 23

issuance of the special use permit is authorized by the local 1 2 liquor control commissioner of the territory in which the property is located, and (iii) the special use permit 3 authorizes the sale of alcoholic liquor for one day or less. 4 5 Alcoholic liquors may be delivered to and sold at any airport belonging to or under the control of a municipality of more 6 7 than 25,000 inhabitants, or in any building or on any golf course owned by a park district organized under the Park 8 9 District Code, subject to the approval of the governing board 10 of the district, or in any building or on any golf course owned 11 by a forest preserve district organized under the Downstate 12 Forest Preserve District Act, subject to the approval of the governing board of the district, or on the grounds within 500 13 feet of any building owned by a forest preserve district 14 15 organized under the Downstate Forest Preserve District Act 16 during times when food is dispensed for consumption within 500 17 feet of the building from which the food is dispensed, subject to the approval of the governing board of the district, or in a 18 19 building owned by a Local Mass Transit District organized under 20 the Local Mass Transit District Act, subject to the approval of the governing Board of the District, or in Bicentennial Park, 21 22 or on the premises of the City of Mendota Lake Park located 23 adjacent to Route 51 in Mendota, Illinois, or on the premises of Camden Park in Milan, Illinois, or in the community center 24 25 owned by the City of Loves Park that is located at 1000 River Park Drive in Loves Park, Illinois, or, in connection with the 26

operation of an established food serving facility during times 1 when food is dispensed for consumption on the premises, and at 2 3 the following aquarium and museums located in public parks: Art Institute of Chicago, Chicago Academy of Sciences, Chicago 4 5 Historical Society, Field Museum of Natural History, Museum of Science and Industry, DuSable Museum of African American 6 7 History, John G. Shedd Aquarium and Adler Planetarium, or at 8 Lakeview Museum of Arts and Sciences in Peoria, or in 9 connection with the operation of the facilities of the Chicago 10 Zoological Society or the Chicago Horticultural Society on land 11 owned by the Forest Preserve District of Cook County, or on any 12 land used for a golf course or for recreational purposes owned by the Forest Preserve District of Cook County, subject to the 13 control of the Forest Preserve District Board of Commissioners 14 and applicable local law, provided that dram shop liability 15 16 insurance is provided at maximum coverage limits so as to hold 17 the District harmless from all financial loss, damage, and harm, or in any building located on land owned by the Chicago 18 19 Park District if approved by the Park District Commissioners, or on any land used for a golf course or for recreational 20 21 purposes and owned by the Illinois International Port District 22 if approved by the District's governing board, or at any 23 airport, golf course, faculty center, or facility in which conference and convention type activities take place belonging 24 25 to or under control of any State university or public community 26 college district, provided that with respect to a facility for

conference and convention type activities alcoholic liquors 1 2 shall be limited to the use of the convention or conference 3 participants or participants in cultural, political or educational activities held in such facilities, and provided 4 5 further that the faculty or staff of the State university or a community college district, 6 public or members of an organization of students, alumni, faculty or staff of the State 7 8 university or a public community college district are active 9 participants in the conference or convention, or in Memorial 10 Stadium on the campus of the University of Illinois at 11 Urbana-Champaign during games in which the Chicago Bears 12 professional football team is playing in that stadium during 13 the renovation of Soldier Field, not more than one and a half 14 hours before the start of the game and not after the end of the 15 third quarter of the game, or in the Pavilion Facility on the 16 campus of the University of Illinois at Chicago during games in 17 which the Chicago Storm professional soccer team is playing in that facility, not more than one and a half hours before the 18 start of the game and not after the end of the third guarter of 19 20 the game, or in the Pavilion Facility on the campus of the 21 University of Illinois at Chicago during games in which the 22 WNBA professional women's basketball team is playing in that 23 facility, not more than one and a half hours before the start of the game and not after the 10-minute mark of the second half 24 25 of the game, or by a catering establishment which has rented 26 facilities from a board of trustees of a public community SB0399 Enrolled - 5 - LRB099 03228 RPS 23236 b

college district, or in a restaurant that is operated by a 1 2 commercial tenant in the North Campus Parking Deck building that (1) is located at 1201 West University Avenue, Urbana, 3 Illinois and (2) is owned by the Board of Trustees of the 4 5 University of Illinois, or, if approved by the District board, on land owned by the Metropolitan Sanitary District of Greater 6 7 Chicago and leased to others for a term of at least 20 years. 8 Nothing in this Section precludes the sale or delivery of 9 alcoholic liquor in the form of original packaged goods in premises located at 500 S. Racine in Chicago belonging to the 10 11 University of Illinois and used primarily as a grocery store by 12 a commercial tenant during the term of a lease that predates 13 University's acquisition of the premises; the but the 14 University shall have no power or authority to renew, transfer, 15 or extend the lease with terms allowing the sale of alcoholic 16 liquor; and the sale of alcoholic liquor shall be subject to 17 all local laws and regulations. After the acquisition by Winnebago County of the property located at 404 Elm Street in 18 Rockford, a commercial tenant who sold alcoholic liquor at 19 20 retail on a portion of the property under a valid license at the time of the acquisition may continue to do so for so long 21 22 as the tenant and the County may agree under existing or future 23 leases, subject to all local laws and regulations regarding the sale of alcoholic liquor. Alcoholic liquors may be provided in long term care 3 facilities owned or operated by a county under Division 5-21 or 4 5 5-22 of the Counties Code, when approved by the facility operator and not in conflict with the regulations of the 6 Illinois Department of Public Health, to residents of the 7 facility who have had their consumption of the alcoholic 8 9 liquors provided approved in writing by a physician licensed to 10 practice medicine in all its branches.

Alcoholic liquors may be delivered to and dispensed in State housing assigned to employees of the Department of Corrections. No person shall furnish or allow to be furnished any alcoholic liquors to any prisoner confined in any jail, reformatory, prison or house of correction except upon a physician's prescription for medicinal purposes.

2 Alcoholic liquors may be delivered to and sold at retail or 3 dispensed for consumption at the Michael Bilandic Building at 160 North LaSalle Street, Chicago IL 60601, after the normal 4 5 business hours of any day care or child care facility located in the building, by (1) a commercial tenant or subtenant 6 7 conducting business on the premises under a lease made pursuant 8 to Section 405-315 of the Department of Central Management 9 Services Law (20 ILCS 405/405-315), provided that such tenant 10 or subtenant who accepts delivery of, sells, or dispenses 11 alcoholic liquors shall procure and maintain dram shop 12 liability insurance in maximum coverage limits and in which the 13 carrier agrees to defend, indemnify, and save harmless the 14 State of Illinois from all financial loss, damage, or harm 15 arising out of the delivery, sale, or dispensing of alcoholic 16 liquors, or by (2) an agency of the State, whether legislative, 17 judicial, or executive, provided that such agency first obtains written permission to accept delivery of and sell or dispense 18 alcoholic liquors from the Director of Central Management 19 20 Services, or by (3) a not-for-profit organization, provided 21 that such organization:

a. obtains written consent from the Department of Central Management Services;

Thompson Center in Chicago, subject to the provisions 17 of Section 7.4 of the State Property Control Act, and 222 South College Street in Springfield, Illinois by (1) a commercial 18 19 tenant or subtenant conducting business on the premises under a lease or sublease made pursuant to Section 405-315 of the 20 Department of Central Management Services Law 21 (20 ILCS 22 405/405-315), provided that such tenant or subtenant who sells 23 or dispenses alcoholic liquors shall procure and maintain dram 24 shop liability insurance in maximum coverage limits and in which the carrier agrees to defend, indemnify and save harmless 25 26 the State of Illinois from all financial loss, damage or harm

arising out of the sale or dispensing of alcoholic liquors, or by (2) an agency of the State, whether legislative, judicial or executive, provided that such agency first obtains written permission to sell or dispense alcoholic liquors from the Director of Central Management Services, or by (3) a not-for-profit organization, provided that such organization:

Alcoholic liquors may be sold at retail or dispensed at the Rockford State Office Building by (1) an agency of the State, whether legislative, judicial or executive, provided that such agency first obtains written permission to sell or dispense alcoholic liquors from the Department of Central Management Services, or by (2) a not-for-profit organization, provided that such organization:

Alcoholic liquors may be sold or delivered in a building 3 that is owned by McLean County, situated on land owned by the 4 5 county in the City of Bloomington, and used by the McLean County Historical Society if the sale or delivery is approved 6 by an ordinance adopted by the county board, and the 7 8 municipality in which the building is located may not prohibit 9 that sale or delivery, notwithstanding any other provision of 10 this Section. The regulation of the sale and delivery of 11 alcoholic liquor in a building that is owned by McLean County, 12 situated on land owned by the county, and used by the McLean 13 County Historical Society as provided in this paragraph is an exclusive power and function of the State and is a denial and 14 limitation under Article VII, Section 6, subsection (h) of the 15 16 Illinois Constitution of the power of a home rule municipality 17 to regulate that sale and delivery.

Alcoholic liquors may be sold or delivered in any building situated on land held in trust for any school district organized under Article 34 of the School Code, if the building is not used for school purposes and if the sale or delivery is approved by the board of education.

Alcoholic liquors may be delivered to and sold at retail in any building owned by the Six Mile Regional Library District, provided that the delivery and sale is approved by the board of trustees of the Six Mile Regional Library District and the

delivery and sale is limited to a maximum of 6 library district 1 2 events per year. The Six Mile Regional Library District shall provide dram shop liability in maximum insurance coverage 3 limits so as to save harmless the library district from all 4 5 financial loss, damage, or harm.

Alcoholic liquors may be delivered to and sold at retail in 6 7 any building owned by a public library district, provided that 8 the delivery and sale is approved by the board of trustees of 9 that public library district and is limited to library fundraising events or programs of a cultural or educational 10 11 nature. Before the board of trustees of a public library 12 district may approve the delivery and sale of alcoholic liquors, the board of trustees of the public library district 13 14 must have a written policy that has been approved by the board of trustees of the public library district governing when and 15 16 under what circumstances alcoholic liquors may be delivered to and sold at retail on property owned by that public library 17 district. The written policy must (i) provide that no alcoholic 18 19 liquor may be sold, distributed, or consumed in any area of the 20 library accessible to the general public during the event or 21 program, (ii) prohibit the removal of alcoholic liquor from the 22 venue during the event, and (iii) require that steps be taken 23 to prevent the sale or distribution of alcoholic liquor to 24 persons under the age of 21. Any public library district that has alcoholic liquor delivered to or sold at retail on property 25 owned by the public library district shall provide dram shop 26

<u>liability insurance in maximum insurance coverage limits so as</u> <u>to save harmless the public library districts from all</u> financial loss, damage, or harm.

Alcoholic liquors may be sold or delivered in buildings owned by the Community Building Complex Committee of Boone County, Illinois if the person or facility selling or dispensing the alcoholic liquor has provided dram shop liability insurance with coverage and in amounts that the Committee reasonably determines are necessary.

10 Alcoholic liquors may be sold or delivered in the building 11 located at 1200 Centerville Avenue in Belleville, Illinois and 12 occupied by either the Belleville Area Special Education 13 District or the Belleville Area Special Services Cooperative.

Alcoholic liquors may be delivered to and sold at the Louis Joliet Renaissance Center, City Center Campus, located at 214 N. Ottawa Street, Joliet, and the Food Services/Culinary Arts Department facilities, Main Campus, located at 1215 Houbolt Road, Joliet, owned by or under the control of Joliet Junior College, Illinois Community College District No. 525.

Alcoholic liquors may be delivered to and sold at Triton
College, Illinois Community College District No. 504.

Alcoholic liquors may be delivered to and sold at the College of DuPage, Illinois Community College District No. 502.

Alcoholic liquors may be delivered to and sold on any property owned, operated, or controlled by Lewis and Clark Community College, Illinois Community College District No. SB0399 Enrolled

1 536.

2 Alcoholic liquors may be delivered to and sold at the building located at 446 East Hickory Avenue in Apple River, 3 Illinois, owned by the Apple River Fire Protection District, 4 5 and occupied by the Apple River Community Association if the alcoholic liquor is sold or dispensed only in connection with 6 7 organized functions approved by the Apple River Community 8 Association for which the planned attendance is 20 or more 9 persons and if the person or facility selling or dispensing the 10 alcoholic liquor has provided dram shop liability insurance in 11 maximum limits so as to hold harmless the Apple River Fire 12 Protection District, the Village of Apple River, and the Apple 13 River Community Association from all financial loss, damage, and harm. 14

Alcoholic liquors may be delivered to and sold at the Sikia Restaurant, Kennedy King College Campus, located at 740 West 63rd Street, Chicago, and at the Food Services in the Great Hall/Washburne Culinary Institute Department facility, Kennedy King College Campus, located at 740 West 63rd Street, Chicago, owned by or under the control of City Colleges of Chicago, Illinois Community College District No. 508.
