9	(a) Unless otherwise stated in this Section, the estimated
10	dates of completion of the redevelopment project and retirement
11	of obligations issued to finance redevelopment project costs
12	(including refunding bonds under Section 11-74.4-7) may not be
13	later than December 31 of the year in which the payment to the
14	municipal treasurer, as provided in subsection (b) of Section
15	11-74.4-8 of this Act, is to be made with respect to ad valorem
16	taxes levied in the 23rd calendar year after the year in which

1 the ordinance approving the redevelopment project area was 2 adopted if the ordinance was adopted on or after January 15, 3 1981.

4 (b) The estimated dates of completion of the redevelopment 5 project and retirement of obligations issued to finance redevelopment project costs (including refunding bonds under 6 Section 11-74.4-7) may not be later than December 31 of the 7 8 year in which the payment to the municipal treasurer as 9 provided in subsection (b) of Section 11-74.4-8 of this Act is 10 to be made with respect to ad valorem taxes levied in the 32nd 11 calendar year after the year in which the ordinance approving the redevelopment project area was adopted if the ordinance was 12 adopted on September 9, 1999 by the Village of Downs. 13

The estimated dates of completion of the redevelopment 14 15 and retirement of obligations issued to finance project 16 redevelopment project costs (including refunding bonds under Section 11-74.4-7) may not be later than December 31 of the 17 18 year in which the payment to the municipal treasurer as 19 provided in subsection (b) of Section 11-74.4-8 of this Act is 20 to be made with respect to ad valorem taxes levied in the 33rd 21 calendar year after the year in which the ordinance approving 22 the redevelopment project area was adopted if the ordinance was adopted on May 20, 1985 by the Village of Wheeling. 23

The estimated dates of completion of the redevelopment project and retirement of obligations issued to finance redevelopment project costs (including refunding bonds under 09900SB0923sam001 -3- LRB099 05513 AWJ 38009 a

Section 11-74.4-7) may not be later than December 31 of the year in which the payment to the municipal treasurer as provided in subsection (b) of Section 11-74.4-8 of this Act is to be made with respect to ad valorem taxes levied in the 28th calendar year after the year in which the ordinance approving the redevelopment project area was adopted if the ordinance was adopted on October 12, 1989 by the City of Lawrenceville.

8 (c) The estimated dates of completion of the redevelopment 9 project and retirement of obligations issued to finance 10 redevelopment project costs (including refunding bonds under 11 Section 11-74.4-7) may not be later than December 31 of the year in which the payment to the municipal treasurer as 12 13 provided in subsection (b) of Section 11-74.4-8 of this Act is 14 to be made with respect to ad valorem taxes levied in the 35th 15 calendar year after the year in which the ordinance approving 16 the redevelopment project area was adopted:

The termination procedures of subsection (b) 17 of Section 11-74.4-8 are not required for these redevelopment 18 project areas in 2009 but are required in 2013. (e) Those dates, for purposes of real property tax increment allocation financing pursuant to Section 11-74.4-8 only, shall be not more than 35 years for redevelopment project areas that were adopted on or after December 16, 1986 and for which at least \$8 million worth of municipal bonds were authorized on or after December 19, 1989 but before January 1, 1990; provided that the municipality elects to extend the life of the redevelopment project area to 35 years by the adoption of an ordinance after at least 14 but not more than 30 days' written notice to the taxing bodies, that would otherwise constitute the joint review board for the redevelopment project area, before the adoption of the ordinance.

8 (f) Those dates, for purposes of real property tax 9 increment allocation financing pursuant to Section 11-74.4-8 10 only, shall be not more than 35 years for redevelopment project 11 areas that were established on or after December 1, 1981 but before January 1, 1982 and for which at least \$1,500,000 worth 12 13 of tax increment revenue bonds were authorized on or after September 30, 1990 but before July 1, 1991; provided that the 14 15 municipality elects to extend the life of the redevelopment 16 project area to 35 years by the adoption of an ordinance after at least 14 but not more than 30 days' written notice to the 17 18 taxing bodies, that would otherwise constitute the joint review board for the redevelopment project area, before the adoption 19 20 of the ordinance.
