9 Section 10. The sum of \$1,000,000, or so much thereof as 10 may be necessary, is appropriated from the Insurance Producer 11 Administration Fund to the Department of Insurance for costs 12 and expenses related to or in support of Get Covered 13 Illinois.

14 Section 15. The sum of \$750,000, or so much thereof as 15 may be necessary, is appropriated from the Insurance Producer 16 Administration Fund to the Department of Insurance for costs 17 and expenses related to or in support of the agency's 18 operations.
