22 Section 110. The sum of \$1,500,000, or so much thereof
23 as may be necessary, is appropriated from the Cemetery

1 Oversight Licensing and Disciplinary Fund to the Department
2 of Financial and Professional Regulation for all costs
3 associated with administration of the Cemetery Oversight Act.

4 Section 115. The sum of \$393,700, or so much thereof as
5 may be necessary, is appropriated from the Community
6 Association Manager Licensing and Disciplinary Fund to the
7 Department of Financial and Professional Regulation for all
8 costs associated with administration of the Community
9 Association Manager Licensing and Disciplinary Act.

10 Section 120. The sum of \$19,000, or so much thereof as
11 may be necessary, is appropriated to the Department of
12 Financial and Professional Regulation from the Real Estate
13 Research and Education Fund for costs associated with the
14 operation of the Office of Real Estate Research at the
15 University of Illinois.

16 Section 125. The sum of \$225,000, or so much thereof as
17 may be necessary, is appropriated from the Athletics
18 Supervision and Regulation Fund to the Department of
19 Financial and Professional Regulation for all costs
20 associated with administration of the Boxing and Full-contact
21 Martial Arts Act.

1 Section 130. The sum of \$1,400,000, or so much thereof
2 as may be necessary, is appropriated from the Savings Bank
3 Regulatory Fund to the Department of Financial and
4 Professional Regulation for the ordinary and contingent
5 expenses of the Department of Financial and Professional
6 Regulation and the Division of Banking, or their successors,
7 in administering and enforcing the Illinois Savings and Loan
8 Act of 1985, the Savings Bank Act, and other laws, rules, and
9 regulations as may apply to the administration and
10 enforcement of the foregoing laws, rules, and regulations, as
11 amended from time to time.

12 Section 135. The sum of \$1,300,000, or so much thereof
13 as may be necessary, is appropriated from the Compassionate
14 Use of Medical Cannabis Fund to the Department of Financial
15 and Professional Regulation for all costs associated with
16 operational expenses of the department in relation to the
17 regulation of medical marijuana.

18 Section 999. Effective date. This Act takes effect July 1,
19 2015.
