

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The sum of \$33,512,100 or so much thereof as
6 may be necessary is appropriated from the Education
7 Assistance Fund to the Board of Trustees of Chicago State
8 University for ordinary and contingent expenses for the
9 fiscal year ending June 30, 2016.

10 Section 10. The sum of \$1,600,000, or so much thereof as
11 may be necessary, is appropriated from the Chicago State
12 University Education Improvement Fund to the Board of
13 Trustees of Chicago State University for any expenses
14 incurred by the university.

15 Section 15. The sum of \$307,000, or so much thereof as
16 may be necessary, is appropriated from the General
17 Professions Dedicated Fund to the Board of Trustees of
18 Chicago State University for costs associated with the
19 development, support or administration of pharmacy practice
20 education or training programs.

1 Section 20. The sum of \$488,800, or so much thereof as
 2 may be necessary, is appropriated from the Education
 3 Assistance Fund to the Board of Trustees of Chicago State
 4 University as a grant to the Financial Assistance Outreach
 5 Center.

6 ARTICLE 2

7 Section 5. The sum of \$22,498,000 or so much thereof as
 8 may be necessary is appropriated from the Education
 9 Assistance Fund to the Board of Trustees of Governors State
 10 University for ordinary and contingent expenses for the
 11 fiscal year ending June 30, 2016.

12 ARTICLE 3

13 Section 5. The following named amounts, or so much
 14 thereof as may be necessary, respectively, for the objects
 15 and purposes hereinafter named, are appropriated from the
 16 General Revenue Fund to the Illinois Community College Board
 17 for ordinary and contingent expenses:

10 Section 10. The sum of \$958,000, or so much thereof as
 11 may be necessary, is appropriated from the General Revenue
 12 Fund to Illinois Community College Board for costs associated
 13 with administering high school equivalency tests.

14 Section 15. The sum of \$6,794,400, or so much thereof as
 15 may be necessary, is appropriated from the General Revenue
 16 Fund to the Illinois Community College Board for grants to
 17 the alternative schools network.

18 Section 20. The amount of \$500,000, or so much thereof
 19 as may be necessary, is appropriated from the General Revenue
 20 Fund to the Illinois Community College Board for Career and
 21 Technical Education Licensed Practical Nurse and Registered
 22 Nurse Preparation.

1 Section 25. The sum of \$60,200, or so much thereof as
 2 may be necessary, is appropriated from the General Revenue
 3 Fund to the Illinois Community College Board for awarding
 4 scholarships to qualifying graduates of the Lincoln's
 5 Challenge Program.

6 Section 30. The sum of \$13,762,200, or so much thereof
 7 as may be necessary, is appropriated from the General Revenue
 8 Fund to the Illinois Community College Board for the City
 9 Colleges of Chicago for educational-related expenses.

10 Section 35. The following named amounts, or so much
 11 thereof as may be necessary, respectively, are appropriated
 12 from the General Revenue Fund to the Illinois Community
 13 College Board for distribution to qualifying public community
 14 colleges for the purposes specified:

20 Section 40. The sum of \$148,400, or so much thereof as
 21 may be necessary, is appropriated from the General Revenue

1 Fund to the Illinois Community College Board for costs
 2 associated with the development, support or administration of
 3 the Illinois Longitudinal Data System.

4 Section 45. The sum of \$1,457,900, or so much thereof as
 5 may be necessary, is appropriated from the General Revenue
 6 Fund to the Illinois Community College Board for grants to
 7 operate the East St. Louis Community College Center.

8 Section 50. The following named amounts, or so much
 9 thereof as may be necessary, are appropriated to the Illinois
 10 Community College Board for all costs associated with career
 11 and technical education activities:

9 Section 65. The sum of \$300,000, or so much thereof as
 10 may be necessary, is appropriated from ICCB Instructional
 11 Development and Enhancement Applications Revolving Fund to
 12 the Illinois Community College Board for costs associated
 13 with maintaining and updating instructional technology.

14 Section 70. The sum of \$1,000,000, or so much thereof as
 15 may be necessary, is appropriated from the High School
 16 Equivalency Testing Fund to the Illinois Community College
 17 Board for costs associated with administering high school
 18 equivalency tests.

19 Section 75. The sum of \$10,000,000, or so much thereof
 20 as may be necessary, is appropriated from the Illinois
 21 Community College Board Contracts and Grants Fund to the

1 Illinois Community College Board to be expended under the
2 terms and conditions associated with the moneys being
3 received, including prior year expenditures.

4 Section 80. The sum of \$480,000, or so much thereof as
5 may be necessary, is appropriated from the ICCB Federal Trust
6 Fund to the Illinois Community College Board for ordinary and
7 contingency expenses of the Board.

8 Section 85. The sum of \$1,250,000, or so much thereof as
9 may be necessary, is appropriated from the ICCB Adult
10 Education Fund to the Illinois Community College Board for
11 operational expenses associated with administration of adult
12 education and literacy activities.

13 Section 90. The sum of \$391,000, or so much thereof as
14 may be necessary, is appropriated from the General Revenue
15 Fund to the Illinois Community College Board for a grant to
16 Rock Valley College for programs for transitioning high
17 school students.

18 Section 95. The sum of \$1,259,300, or so much thereof as
19 may be necessary, is appropriated from the General Revenue
20 Fund to the Illinois Community College Board to reimburse the
21 following colleges for costs associated with the Illinois
