17 funds to be made available from collections from claims filed

19 Section 125. The sum of \$3,000,000, or so much thereof  
20 as may be necessary, is appropriated from the Road Fund to

22 the State Radio Communications for the 21st Century (STARCOM)  
23 program.

1           Section 130. The sum of \$100,000, or so much thereof as  
2 may be necessary, is appropriated from the Road Fund to the  
3 Department of Transportation for costs associated with the  
4 Technology Transfer Center, including the purchase of  
5 equipment, media initiatives, and training, provided that  
6 such expenditures do not exceed funds to be made available by  
7 the federal government for this purpose.

8           Section 135. The sum of \$100,000, or so much thereof as  
9 may be necessary, is appropriated from the Road Fund to the  
10 Illinois Department of Transportation for costs associated  
11 with Illinois Terrorism Task Force, that consist of approved  
12 purchases for homeland security provided such expenditures do  
13 not exceed funds made available by the federal government for  
14 this purpose.

15           Section 140. The sum of \$1,000,000, or so much thereof  
16 as may be necessary, is appropriated from the Road Fund to  
17 the Illinois Department of Transportation for costs incurred  
18 by the Department's response to natural disasters,  
19 emergencies and acts of terrorism that receive Presidential  
20 and/or State Disaster Declaration status. These costs would  
21 include, but not be limited to, the Department's fuel costs,  
22 cost of materials and cost of equipment rentals. This

1 appropriation is in addition to the Department's other  
2 appropriations for District and Central Office operations.

3 Section 145. The sum of \$400,000, or so much thereof as  
4 may be necessary, is appropriated from the Transportation  
5 Safety Highway Hire-back Fund to the Department of  
6 Transportation for agreements with the Illinois Department of  
7 State Police to provide patrol officers in highway  
8 construction work zones.

9 FOR TRAFFIC SAFETY

10 Section 150. The sum of \$600,000, or so much thereof as  
11 may be necessary, is appropriated from the Road Fund to the  
12 Department of Transportation for programs related to  
13 distracted driving, provided such amounts do not exceed funds  
14 to be made available from the federal government for this  
15 purpose.

16 Section 155. The sum of \$3,000,000, or so much thereof  
17 as may be necessary, is appropriated from the Road Fund to  
18 the Department of Transportation for costs associated with  
19 highway safety media campaigns, provided such amounts do not  
20 exceed funds to be made available from the federal  
21 government.

1 Section 160. The sum of \$800,000, or so much thereof as  
2 may be necessary, is appropriated from the Road Fund to the  
3 Department of Transportation for costs associated with Safety  
4 and Security Oversight as set forth in MAP-21.

5 Section 165. The sum of \$4,000,000, or so much thereof  
6 as may be necessary, is appropriated from the Federal Mass  
7 Transit Trust Fund to the Department of Transportation for  
8 federal reimbursement of costs associated with Safety and  
9 Security Oversight as set forth in MAP-21.

11 Section 170. The sum of \$1,250,000, or so much thereof
