1 AN ACT concerning appropriations.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 ARTICLE 1

Section 5. The amount of \$1,411,700, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Governor's Office of Management and Budget to meet its operational expenses for the fiscal year ending June 30, 2016.

Section 10. The amount of \$1,543,100, or so much thereof as may be necessary, is appropriated from the Capital Development Fund to the Governor's Office of Management and Budget for ordinary and contingent expenses associated with the sale and administration of General Obligation bonds.

Section 15. The amount of \$650,000, or so much thereof as may be necessary, is appropriated from the Build Illinois Bond Fund to the Governor's Office of Management and Budget for ordinary and contingent expenses associated with the sale and administration of Build Illinois bonds.

1 Governor.

2 Section 40. The sum of \$3,100,000, or so much thereof as 3 may be necessary, is appropriated from the 4 Accountability and Transparency Fund to the Governor's Office 5 of Management and Budget for all costs associated with the implementation and administration of the Grant Accountability 6 7 and Transparency Act, including refunds and prior year costs.
