1 AMENDMENT TO SENATE BILL 2040

2 AMENDMENT NO. _____. Amend Senate Bill 2040, by
3 inserting the following on page 14, after line 21:

4 "ARTICLE 11

5 "Personnel expenditure" means an expenditure for personal
6 services, group insurance for employees paid out of funds
7 other than the General Revenue Fund, State contributions to
8 Social Security, and State contributions to a State
9 retirement system.

10 "State agency" means any agency, authority, board,
11 commission, department, or other instrumentality of the State
12 government to which an appropriation for personnel
13 expenditures was paid in Fiscal Year 2015. "State agency"
14 does not include any State university or community college

1 district.

2 "Applicable State fund" means, with respect to a State
3 agency, the General Revenue Fund or other State fund from
4 which monies were appropriated in Fiscal Year 2015 to the
5 State agency for personnel expenditures.

6 Section 10. The amounts necessary from the Applicable
7 State funds are appropriated to the Office of the Comptroller
8 for personnel expenditures of State agencies, as jointly
9 certified by the State agency and the Governor's Office of
10 Management and Budget, for each payroll period during which
11 appropriations that provide for personnel expenditures have
12 not been made available to the State agency for Fiscal Year
13 2016, provided that the amounts appropriated shall not exceed
14 the amounts appropriated for the same purpose in Fiscal Year
15 2015.

16 Section 15. The amounts necessary from the Applicable
17 State funds are appropriated to the Office of the Comptroller
18 for personnel expenditures for each payroll period during
19 which appropriations that provide for personnel expenditures
20 have not been made available for Fiscal Year 2016, provided
21 that the amounts appropriated shall not exceed the amounts
22 appropriated for the same purpose in Fiscal Year 2015.

1 Section 20. The amounts necessary from the Applicable
2 State funds are appropriated to the Office of the Secretary
3 of State for personnel expenditures for each payroll period
4 during which appropriations that provide for personnel
5 expenditures have not been made available for Fiscal Year
6 2016, provided that the amounts appropriated shall not exceed
7 the amounts appropriated for the same purpose in Fiscal Year
8 2015.

9 Section 25. The amounts necessary from the Applicable
10 State funds are appropriated to the Office of the Attorney
11 General for personnel expenditures for each payroll period
12 during which appropriations that provide for personnel
13 expenditures have not been made available for Fiscal Year
14 2016, provided that the amounts appropriated shall not exceed
15 the amounts appropriated for the same purpose in Fiscal Year
16 2015.

17 Section 30. The amounts necessary from the Applicable
18 State funds are appropriated to the Office of the State
19 Treasurer for personnel expenditures for each payroll period
20 during which appropriations that provide for personnel
21 expenditures have not been made available for Fiscal Year
22 2016, provided that the amounts appropriated shall not exceed
23 the amounts appropriated for the same purpose in Fiscal Year
