Introduced 2/16/2016, by Sen. Mattie Hunter

SYNOPSIS AS INTRODUCED:

Appropriates specified amounts from the General Revenue Fund, the Illinois Affordable Housing Trust Fund, the Health and Human Services Medicaid Trust Fund, and the Assistance to the Homeless Fund to the Department of Human Services for grants to family and community services and mental health programs. Appropriates specified amounts from the Rental Housing Support Program Fund and the Illinois Affordable Housing Trust Fund to the Department of Revenue for various purposes. Effective immediately.

1 AN ACT concerning appropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 ARTICLE 1 Section 5. 13	various regions pursuant to Sections 3 and 4 of the Community
14	Services Act and the Community Mental Health Act:

17	Payable from the General Revenue Fund:

19	Section 15. The sum of \$34,450,000, or so much thereof as
20	may be necessary, is appropriated to the Department of Human
21	Services from the Health and Human Services Medicaid Trust
22	Fund for awards and grants to developmental disabilities or
23	mental health programs.

1 ARTICLE 2

2	Section 5. The following named sums, or so much thereof
3	as may be necessary, respectively, for the objects and
4	purposes hereinafter named, are appropriated to meet the
5	ordinary and contingent expenses of the Department of
6	Revenue:
7	PAYABLE FROM RENTAL HOUSING SUPPORT PROGRAM FUND
8	For administration of the Rental
9	Housing Support Program
10	PAYABLE FROM ILLINOIS AFFORDABLE HOUSING TRUST FUND
11	For administration of the Illinois
12	Affordable Housing Act4,100,000
13	Section 10. The sum of \$65,000,000, or so much thereof as
14	may be necessary, is appropriated from the Illinois Affordable
15	Housing Trust Fund to the Department of Revenue for grants,

Housing Trust Fund to the Department of Revenue for grants, (down payment assistance, rental subsidies, security deposit subsidies, technical assistance, outreach, building an organization's capacity to develop affordable housing projects and other related purposes), mortgages, loans, or for the purpose of securing bonds pursuant to the Illinois Affordable Housing Act, administered by the Illinois Housing Development Authority.

- 1 Section 15. The sum of \$3,000,000, or so much thereof as
- 2 may be necessary, is appropriated from the Illinois
- 3 Affordable Housing Trust Fund to the Department of Revenue
- 4 for grants to other state agencies for rental assistance,
- 5 supportive living and adaptive housing.
- 6 Section 20. The sum of \$25,000,000, new appropriation,
- 7 is appropriated and the sum of \$15,000,000, or so much
- 8 thereof as may be necessary and as remains unexpended at the
- 9 close of business on June 30, 2015, from appropriations and
- 10 reappropriations heretofore made in Article 35, Section 30 of
- 11 Public Act 98-0679 is reappropriated from the Federal HOME
- 12 Investment Trust Fund to the Department of Revenue for the
- 13 Illinois HOME Investment Partnerships Program administered by
- 14 the Illinois Housing Development Authority.
- 15 Section 25. The sum of \$8,500,000, or so much thereof as
- 16 may be necessary, is appropriated from the Foreclosure
- 17 Prevention Program Fund to the Department of Revenue for
- administration by the Illinois Housing Development Authority,
- 19 for grants and administrative expenses pursuant to the
- 20 Foreclosure Prevention Program.
- Section 30. The sum of \$11,000,000, or so much thereof as

- 1 may be necessary, is appropriated from the Foreclosure
- 2 Prevention Program Graduated Fund to the Department of
- 3 Revenue for administration by the Illinois Housing
- 4 Development Authority, for grants and administrative expenses
- 5 pursuant to the Foreclosure Prevention Program.
- 6 Section 35. The sum of \$15,000,000, or so much thereof as
- 7 may be necessary, is appropriated from the Abandoned
- 8 Residential Property Municipality Relief Fund to the
- 9 Department of Revenue for administration by the Illinois
- 10 Housing Development Authority, for grants and administrative
- 11 expenses pursuant to the Abandoned Residential Property
- 12 Municipality Relief Program.
- 13 Section 40. The sum of \$25,000,000, new appropriation, is
- appropriated and the sum of \$50,000,000, or so much thereof
- as may be necessary and as remains unexpended at the close of
- business on June 30, 2015, from appropriations heretofore
- 17 made in Article 35, Section 5 of Public Act 98-0064 is
- 18 reappropriated from the Rental Housing Support Program Fund
- 19 to the Department of Revenue for current and prior year costs
- of the Rental Housing Support Program administered by the
- 21 Illinois Housing Development Authority.

- 1 Section 998. The appropriation authority granted in this
- 2 Act shall be valid for costs incurred July 1, 2015 through
- 3 June 30, 2016.
- 4 ARTICLE 999
- 5 Section 99. Effective date. This Act takes effect upon
- 6 becoming law.
