1 AMENDMENT TO SENATE BILL 3058

2 AMENDMENT NO. _____. Amend Senate Bill 3058 by replacing
3 everything after the enacting clause with the following:

4 "Section 5. The Public Community College Act is amended by
5 changing Section 2-1 as follows:

6 (110 ILCS 805/2-1) (from Ch. 122, par. 102-1)

7 Sec. 2-1. There is created the ~~the~~ Illinois Community
8 College Board hereinafter referred to as the "State Board". The
9 State Board shall consist of 12 members as follows: a nonvoting
10 student member selected by the recognized advisory committee of
11 students of the Illinois Community College Board, this student
12 to serve for a term of one year beginning on July 1 of each
13 year, except that the student member initially selected shall
14 serve a term beginning on the date of such selection and
15 expiring on the next succeeding June 30, and except that any
16 student member or former student member may be selected by the

1 recognized advisory committee of students of the State Board to
2 serve a second term as the nonvoting student member of the
3 State Board; and 11 members, one of whom shall be a senior
4 citizen age 60 or over, to be appointed by the Governor by and
5 with the advice and consent of the Senate. Beginning on July 1,
6 2005, one of the 11 members appointed by the Governor, by and
7 with the advice and consent of the Senate, must be a faculty
8 member at an Illinois public community college. Also beginning
9 on July 1, 2005, one of the 11 members appointed by the
10 Governor, by and with the advice and consent of the Senate,
11 must be a member of the board of trustees of a public community
12 college district. After the effective date of this amendatory
13 Act of the 97th General Assembly, one of the 11 members to be
14 appointed by the Governor, by and with the advice and consent
15 of the Senate, must be the president of a public community
16 college, the Chancellor of City Colleges of Chicago (Community
17 College District No. 508), or the Chief Executive Officer of
18 Illinois Eastern Community Colleges (Community College
19 District No. 529). The membership requirements set forth in
20 this Section apply only to the State Board and shall have no
21 effect on the membership of the board of trustees of a
22 community college district. The members first appointed under
23 this amendatory Act of 1984 shall serve for a term of 6 years.
24 After the expiration of the terms of the office of the members
25 first appointed to the State Board, their respective successors
26 shall hold office for a term of 6 years and until their

1 successors are qualified and seated. In the event of vacancies
2 on the State Board in offices appointed by the Governor
3 occurring during a recess of the Senate, the Governor shall
4 have the power to make temporary appointments until the next
5 meeting of the Senate, when the vacancy shall be filled by
6 nomination to be confirmed by the Senate.
