- 2 Be it enacted by the People of the State of Illinois,
- 3 represented in the General Assembly:
- 4 Section 5. The State Finance Act is amended by adding
- 5 Section 5.545 as follows:

- 7 <u>Sec. 5.545. The Pet Overpopulation Control Fund.</u>
- 8 Section 10. The Illinois Vehicle Code is amended by
- 9 adding Section 3-648 as follows:

- 11 <u>Sec. 3-648. Pet Friendly license plates.</u>
- 12 <u>(a) The Secretary, upon receipt of an application made</u>
- in the form prescribed by the Secretary, may issue special
- 14 registration plates designated as Pet Friendly license
- 15 plates. The special plates issued under this Section shall
- 16 <u>be affixed only to passenger vehicles of the first division,</u>
- 17 <u>motor vehicles of the second division weighing not more than</u>

8,000 pounds, and recreational vehicles as defined in Section

- 19 <u>1-169 of this Code. Plates issued under this Section shall</u>
- 20 <u>expire according to the multi-year procedure established by</u>
- 21 <u>Section 3-414.1 of this Code.</u>
- 22 (b) The design and color of the plates is wholly within
- 23 the discretion of the Secretary, except that the phrase "I am
- 24 pet friendly" shall be on the plates. The Secretary may allow
- 25 the plates to be issued as vanity plates or personalized
- 26 plates under Section 3-405.1 of the Code. The Secretary

29 (c) An applicant for the special plate shall be charged

- 1 <u>a \$40 fee for original issuance in addition to the</u>
- 2 appropriate registration fee. Of this additional fee, \$25
- 3 shall be deposited into the Pet Overpopulation Control Fund
- 4 and \$15 shall be deposited into the Secretary of State
- 5 Special License Plate Fund, to be used by the Secretary to
- 6 <u>help defray the administrative processing costs.</u>
- For each registration renewal period, a \$27 fee, in
- 8 addition to the appropriate registration fee, shall be
- 9 <u>charged. Of this additional fee, \$25 shall be deposited into</u>

- into the Secretary of State Special License Plate Fund.
