1 AN ACT concerning Illinois Correctional Employee Memorial

- 3 Be it enacted by the People of the State of Illinois,
- 4 represented in the General Assembly:
- 5 Section 5. The State Finance Act is amended by adding
- 6 Section 5.543 as follows:
- 7 (30 ILCS 105/5.543 new)
- 8 <u>Sec. 5.543. The Illinois Correctional Employee Memorial</u>
- 9 <u>Fund.</u>
- 10 Section 10. The Illinois Vehicle Code is amended by
- 11 adding Section 3-648 as follows:
- 12 (625 ILCS 5/3-648 new)
- Sec. 3-648. Illinois Correctional Employee Memorial
- 14 <u>license plates.</u>
- 15 <u>(a) The Secretary, upon receipt of an application made</u>
- in the form prescribed by the Secretary, may issue special
- 17 <u>registration plates designated as Illinois Correctional</u>
- 18 <u>Employee Memorial license plates. The special plates issued</u>
- 19 <u>under this Section shall be affixed only to passenger</u>
- 20 <u>vehicles of the first division and motor vehicles of the</u>
- 21 <u>second division weighing not more than 8,000 pounds.</u> Plates
- 22 <u>issued under this Section shall expire according to the</u>
- 23 <u>multi-year procedure established by Section 3-414.1 of this</u>
- 24 <u>Code</u>.
- 25 (b) The design and color of the plates is wholly within
- 26 <u>the discretion of the Secretary. The Secretary may allow the</u>
- 27 plates to be issued as vanity or personalized plates under
- 28 <u>Section 3-405.1 of this Code. The Secretary shall prescribe</u>
- 29 <u>stickers or decals as provided under Section 3-412 of this</u>

- 1 <u>Code</u>.
- 2 (c) An applicant for the special plate shall be charged
- 3 <u>a \$25 fee for original issuance in addition to the</u>
- 4 appropriate registration fee. Of this fee, \$10 shall be
- 5 <u>deposited into the Illinois Correctional Employee Memorial</u>
- 6 Fund and \$15 shall be deposited into the Secretary of State
- 7 Special License Plate Fund, to be used by the Secretary to
- 8 <u>help defray the administrative processing costs.</u>
- 9 For each registration renewal period, a \$17 fee, in
- 10 <u>addition to the appropriate registration fee, shall be</u>
- 11 charged. Of this fee, \$15 shall be deposited into the
- 12 <u>Illinois Correctional Employee Memorial Fund and \$2 shall be</u>
- 13 <u>deposited into the Secretary of State Special License Plate</u>
- 14 <u>Fund</u>.
- 15 (d) The Illinois Correctional Employee Memorial Fund is
- 16 <u>created as a special fund in the State treasury. All money</u>
- in the Illinois Correctional Employee Memorial Fund shall,
- 18 <u>subject to appropriation by the General Assembly and approval</u>
- 19 by the Secretary, be used by the Department of Corrections
- 20 <u>for construction of the Illinois Correctional Employee</u>
- 21 Memorial, to be located at the State Capitol grounds in
- 22 Springfield, Illinois. Upon the completion of the Memorial,
- 23 <u>the Department of Corrections shall certify to the State</u>
- 24 <u>Treasurer that construction of the Memorial has been</u>
- 25 <u>completed</u>. <u>Upon the certification by the Department of</u>
- 26 <u>Corrections, the State Treasurer shall transfer all moneys in</u>
- 27 <u>the Fund and any future deposits into the Secretary of State</u>
- 28 Special License Plate Fund.
- 29 Section 99. Effective date. This Act takes effect upon
- 30 becoming law.
