- 4 Section 5. The Illinois Public Aid Code is amended by
- 5 changing Section 11-26.1 and adding Section 12-4.25d as

- 8 Sec. 11-26.1. Drug Utilization Review.
- 9 (a) The Illinois Department shall, within the time
- 10 frames mandated by federal law, implement a Drug Utilization
- 11 Review Program (DUR), designed to decrease overutilization of
- 12 drugs through both prospective and retrospective utilization
- 13 review. The Illinois Department shall determine the content
- of the DUR by rule. <u>Prescriptions filled or refilled under</u>
- 15 <u>subsection</u> (b) of <u>Section 12-4.25d are not subject to the</u>
- 16 <u>DUR</u>.
- 17 (b) The Illinois Department may implement this Section
- 18 as added by this amendatory Act of 1991 through the use of
- 19 emergency rules in accordance with the provisions of Section
- 20 5.02 of the Illinois Administrative Procedure Act. For

- 28 program; prescription drug discount benefit.
- 29 (a) A pharmacy must comply with subsection (b) as a
- 30 <u>condition of participation in the medical assistance program</u>

<u>under Article V.</u>

- 2 (b) If a person requests that a pharmacy fill or refill
- 3 <u>a valid prescription for a prescription drug and also</u>
- 4 presents the pharmacy with satisfactory proof that the person
- 5 for whom the prescription is written is a Medicare
- 6 <u>beneficiary or a beneficiary of pharmaceutical assistance</u>
- 7 under the Senior Citizens and Disabled Persons Property Tax
- 8 Relief and Pharmaceutical Assistance Act, the pharmacy may
- 9 <u>not charge a price for filling or refilling the prescription</u>
- that exceeds the sum of the following:

- 14 Relief and Pharmaceutical Assistance Act. The information
- 15 <u>must include a description of the prescription drug discount</u>
- 16 <u>benefit available under subsection (b), instructions for</u>
- 17 <u>obtaining the benefit, and prescription drug price</u>
- 18 <u>information</u> to ensure that prescription drug discount
- 19 <u>beneficiaries are aware of the maximum prices that pharmacies</u>
- 20 <u>may charge for prescription drugs under subsection (b). The</u>
- 21 <u>Illinois Department shall provide this information by</u>
- 22 <u>appropriate means, including the Internet.</u>
- 23 (h) The Illinois Department shall execute interagency
- 24 agreements with the Department on Aging and the Department of
- 25 Revenue as necessary to implement subsection (g). The
- 26 <u>agreements shall include provisions for assisting persons</u>
- 27 <u>entitled to the prescription drug discount benefit under</u>
- 28 <u>subsection (b) in obtaining that benefit.</u>
- 29 (i) If coverage of prescription drugs is added to the
- 30 <u>benefits available under the Medicare program, the Illinois</u>
- 31 <u>Department shall promptly report that fact to the General</u>
- 32 Assembly. It is the General Assembly's intent that under
- 33 <u>those circumstances the General Assembly shall evaluate the</u>
- 34 <u>continued implementation of this Section.</u>
