AMENDMENT TO HOUSE BILL 3247

AMENDMENT NO. ____. Amend House Bill 3247 on page 11, line 29, after "affected" by inserting "pursuant to Sections fthrough 40"; and

5 on page 12, after line 1, by inserting the following:

6 "Section 905. Upon the payment of any sum required by 7 the Cook County Forest Preserve District, and subject to the 8 conditions set forth in Section 910 of this Act, the Cook 9 County Forest Preserve is authorized to convey by quitclaim 10 deed all of its right, title, and interest in and to the 11 following described lands in Cook County, Illinois:

PARCEL A

47, and 48 in block 6 in Indian Highlands, a 13 Lot 46, subdivision of all that part of the west 225 acres of the 14 north 32/80ths of the north Section of Robinson's Reserve 15 in Township 40 North, Range 12 East of the Third 16 Principal Meridian, lying east of a line as follows: 17 Beginning at a point on the North line of the North 18 Section 40.05 chains east of the Northwest corner of the 19 North Section running thence South 22 1/4 degrees East 20 4.40 chains; thence South 63 1/2 degrees West 11.73 21 22 chains; thence North 55 1/2 degrees West 4.80 chains;

Section 910. The Cook County Forest Preserve District shall obtain a certified copy of the portions of this Act containing the title, the enacting clause, the effective date, Section 905, and this Section within 60 days after its effective date and upon receipt of the required payment, if payment is required, shall record the certified document in the Recorder's Office in Cook County.".
