AN ACT concerning appropriation reporting.

Be it enacted by the People of the State of Illinois,represented in the General Assembly:

Section 5. The Illinois Economic and Fiscal Commission
Act is amended by changing Section 3 as follows:

6 (25 ILCS 155/3) (from Ch. 63, par. 343)

7 Sec. 3. The Commission shall:

8 (1) Study from time to time and report to the General9 Assembly on economic development and trends in the State.

10 (2) Make such special economic and fiscal studies as it 11 deems appropriate or desirable or as the General Assembly may 12 request.

13 (3) Based on its studies, recommend such State fiscal 14 and economic policies as it deems appropriate or desirable to 15 improve the functioning of State government and the economy 16 of the various regions within the State.

(4) Prepare annually a State economic report.

18 (5) Provide information for all appropriate legislative
19 organizations and personnel on economic trends in relation to
20 long range planning and budgeting.

(6) Study and make such recommendations as it deems appropriate to the General Assembly on local and regional economic and fiscal policy and on federal fiscal policy as it may affect Illinois.

25 (7) Review capital expenditures, appropriations and authorizations for both the State's general obligation and 26 27 revenue bonding authorities. At the direction of the Commission, specific reviews may include economic feasibility 28 29 reviews of existing or proposed revenue bond projects to determine the accuracy of the original estimate of useful 30 life of the projects, maintenance requirements and ability to 31

meet debt service requirements through their operating
 expenses.

(8) Receive and review all executive agency and revenue 3 4 bonding authority annual and 3 year plans. The Commission 5 shall prepare a consolidated review of these plans, an б updated assessment of current State agency capital plans, a 7 report on the outstanding and unissued bond authorizations, an evaluation of the State's ability to market further bond 8 9 issues and shall submit them as the "Legislative Capital Plan Analysis" to the House and Senate Appropriations Committees 10 11 at least once a year. The Commission shall annually submit to the General Assembly on the first Wednesday of April a 12 State's long-term capital needs, with 13 report on the particular emphasis upon and detail of the 5-year period in 14 the immediate future. 15

16 (9) Study and make recommendations it deems appropriate 17 to the General Assembly on State bond financing, bondability 18 guidelines, and debt management. At the direction of the 19 Commission, specific studies and reviews may take into 20 consideration short and long-run implications of State 21 bonding and debt management policy.

(10) Comply with the provisions of the "State DebtImpact Note Act" as now or hereafter amended.

24 (11) Comply with the provisions of the Pension Impact25 Note Act, as now or hereafter amended.

(12) By August 1st of each year, the Commission must 26 27 prepare and cause to be published a summary report of State appropriations for the State fiscal year beginning the 28 previous July 1st. The summary report must discuss major 29 30 categories of appropriations, the issues the General Assembly 31 faced in allocating appropriations, comparisons with appropriations for previous State fiscal years, and other 32 matters helpful in providing the citizens of Illinois with an 33 34 overall understanding of appropriations for that fiscal year.

1 The summary report must be written in plain language and 2 designed for readability. Publication must be in newspapers 3 of general circulation in the various areas of the State to 4 ensure distribution statewide. The summary report must also 5 be published on the General Assembly's web site.

6 The requirement for reporting to the General Assembly 7 shall be satisfied by filing copies of the report with the Speaker, the Minority Leader and the Clerk of the House of 8 9 Representatives and the President, the Minority Leader and the Secretary of the Senate and the Legislative Research 10 Unit, as required by Section 3.1 of "An Act to revise the law 11 in relation to the General Assembly", approved February 25, 12 1874, as amended, and filing such additional copies with the 13 State Government Report Distribution Center for the General 14 Assembly as is required under paragraph (t) of Section 7 of 15 16 the State Library Act.
