33 <u>The Director may terminate the appointment of any member</u>

34 for good cause, including but not limited to (i) unjustified

absences from Board meetings or other failure to meet Board 2 responsibilities, (ii) failure to recuse himself or herself when required by subsection (c) of this Section or Department 3 4 rule, or (iii) failure to maintain the professional position required by Department rule. No member of the Board may have 5 a pending or indicated report of child abuse or neglect or a 6 pending complaint or criminal conviction of any of the 7 offenses set forth in paragraph (b) of Section 4.2 of the 8 9 Child Care Act of 1969. 10 The members of the Board shall receive no compensation 11 for the performance of their duties as members, but each member shall be reimbursed for his or her reasonable and 12 13 necessary expenses incurred in attending the meetings of the 14 Board. 15 (c) The Board shall make recommendations to the Director regarding licensure rules. Board members must recuse 16 17 themselves from sitting on any matter involving an employee of a child welfare agency at which the Board member is an 18 employee or contractual employee. The Board shall make a 19 final determination concerning revocation, suspension, or 20 2.1 reinstatement of an employee's direct child welfare service 22 license after a hearing conducted under the Department's rules. Upon notification of the manner of the vote to all the 23 24 members, votes on a final determination may be cast in person, by telephonic or electronic means, or by mail at the 25 discretion of the chairperson. A simple majority of the 26 members appointed and serving is required when Board members 27 vote by mail or by telephonic or electronic means. A 28 29 majority of the currently appointed and serving Board members constitutes a quorum. A majority of a quorum is required 30 31 when a recommendation is voted on during a Board meeting. A vacancy in the membership of the Board shall not impair the 32 right of a quorum to perform all the duties of the Board. 33 34 Board members are not personally liable in any action based

- 1 upon a disciplinary proceeding or otherwise for any action
- 2 <u>taken in good faith as a member of the Board.</u>
- 3 (d) The Director may assign Department employees to
- 4 provide staffing services to the Board. The Department must
- 5 promulgate any rules necessary to implement and administer
- 6 <u>the requirements of this Section.</u>
