1 AN ACT to amend the State Finance Act by changing Section

- 3 Be it enacted by the People of the State of Illinois,
- 4 represented in the General Assembly:
- 5 Section 5. The State Finance Act is amended by changing
- 6 Section 8.3 as follows:
- 7 (30 ILCS 105/8.3) (from Ch. 127, par. 144.3)
- 8 Sec. 8.3. Money in the Road Fund shall, if and when the
- 9 State of Illinois incurs any bonded indebtedness for the
- 10 construction of permanent highways, be set aside and used for
- 11 the purpose of paying and discharging annually the principal
- 12 and interest on that bonded indebtedness then due and
- 13 payable, and for no other purpose. The surplus, if any, in
- 14 the Road Fund after the payment of principal and interest on
- 15 that bonded indebtedness then annually due shall be used as
- 16 follows:
- 17 first -- to pay the cost of administration of
- 18 Chapters 2 through 10 of the Illinois Vehicle Code,
- 19 except the cost of administration of Articles I and II of
- 20 Chapter 3 of that Code; and
- 21 secondly -- for expenses of the Department of
- 22 Transportation for construction, reconstruction,
- improvement, repair, maintenance, operation, and
- 24 administration of highways in accordance with the
- 25 provisions of laws relating thereto, or for any purpose
- related or incident to and connected therewith, including
- 27 the separation of grades of those highways with railroads
- and with highways and including the payment of awards
- 29 made by the Industrial Commission under the terms of the
- 30 Workers' Compensation Act or Workers' Occupational
- 31 Diseases Act for injury or death of an employee of the

Division of Highways in the Department of Transportation; or for the acquisition of land and the erection of buildings for highway purposes, including the acquisition of highway right-of-way or for investigations to the reasonably anticipated future highway determine needs; or for making of surveys, plans, specifications and estimates for and in the construction and maintenance flight strips and of highways necessary to provide access to military and naval reservations, to defense industries and defense-industry sites, and to the sources of raw materials and for replacing existing highways and highway connections shut off from general public use at military and naval reservations and defense-industry sites, or for the purchase of right-of-way, except that the State shall be reimbursed in full for any expense incurred in building the flight strips; or for the operating and maintaining of highway garages; or for patrolling and policing public highways the and conserving the peace; or for any of those purposes or any other purpose that may be provided by law.

Appropriations for any of those purposes are payable from the Road Fund. Appropriations may also be made from the Road Fund for the administrative expenses of any State agency that are related to motor vehicles or arise from the use of motor vehicles.

Beginning with fiscal year 1980 and thereafter, no Road Fund monies shall be appropriated the following to agencies Departments or of State government administration, grants, or operations; but this limitation is not a restriction upon appropriating for those purposes any Road Fund monies that are eligible for federal reimbursement;

- 1. Department of Public Health;
- 2. Department of Transportation, only with respect to subsidies for one-half fare Student Transportation and

- 1 Reduced Fare for Elderly;
- Department of Central Management Services,
- 3 except for expenditures incurred for group insurance
- 4 premiums of appropriate personnel;
- 5 4. Judicial Systems and Agencies.
- 6 Beginning with fiscal year 1981 and thereafter, no Road
- 7 Fund monies shall be appropriated to the following
- 8 Departments or agencies of State government for
- 9 administration, grants, or operations; but this limitation is
- 10 not a restriction upon appropriating for those purposes any
- 11 Road Fund monies that are eligible for federal reimbursement:
- 1. Department of State Police, except for
- expenditures with respect to the Division of Operations;
- 2. Department of Transportation, only with respect
- to Intercity Rail Subsidies and Rail Freight Services.
- 16 Beginning with fiscal year 1982 and thereafter, no Road
- 17 Fund monies shall be appropriated to the following
- 18 Departments or agencies of State government for
- 19 administration, grants, or operations; but this limitation is
- 20 not a restriction upon appropriating for those purposes any
- 21 Road Fund monies that are eligible for federal reimbursement:
- 22 Department of Central Management Services, except for awards
- 23 made by the Industrial Commission under the terms of the
- 24 Workers' Compensation Act or Workers' Occupational Diseases
- 25 Act for injury or death of an employee of the Division of
- 26 Highways in the Department of Transportation.
- 27 Beginning with fiscal year 1984 and thereafter, no Road
- 28 Fund monies shall be appropriated to the following
- 29 Departments or agencies of State government for
- 30 administration, grants, or operations; but this limitation is
- 31 not a restriction upon appropriating for those purposes any
- 32 Road Fund monies that are eligible for federal reimbursement:
- 1. Department of State Police, except not more than
- 34 40% of the funds appropriated for the Division of

1 Operations;

2. State Officers.

Beginning with fiscal year 1984 and thereafter, no Road Fund monies shall be appropriated to any Department or agency of State government for administration, grants, or operations except as provided hereafter; but this limitation is not a restriction upon appropriating for those purposes any Road Fund monies that are eligible for federal reimbursement. It shall not be lawful to circumvent the above appropriation limitations by governmental reorganization or other methods. Appropriations shall be made from the Road Fund only in accordance with the provisions of this Section.

Money in the Road Fund shall, if and when the State of Illinois incurs any bonded indebtedness for the construction of permanent highways, be set aside and used for the purpose of paying and discharging during each fiscal year the principal and interest on that bonded indebtedness as it becomes due and payable as provided in the Transportation Bond Act, and for no other purpose. The surplus, if any, in the Road Fund after the payment of principal and interest on that bonded indebtedness then annually due shall be used as follows:

first -- to pay the cost of administration of Chapters 2 through 10 of the Illinois Vehicle Code; and

secondly -- no Road Fund monies derived from fees, excises, or license taxes relating to registration, operation and use of vehicles on public highways or to fuels used for the propulsion of those vehicles, shall be appropriated or expended other than for costs of administering the laws imposing those fees, excises, and license taxes, statutory refunds and adjustments allowed thereunder, administrative costs of the Department of Transportation, payment of debts and liabilities incurred in construction and reconstruction of public highways and

bridges, acquisition of rights-of-way for and the cost of construction, reconstruction, maintenance, repair, and operation of public highways and bridges under the direction and supervision of the State, political subdivision, or municipality collecting those monies, and the costs for patrolling and policing the public highways (by State, political subdivision, or municipality collecting that money) for enforcement of traffic laws. The separation of grades of such highways with railroads and costs associated with protection of at-grade highway and railroad crossing shall also be permissible.

Appropriations for any of such purposes are payable from the Road Fund or the Grade Crossing Protection Fund as provided in Section 8 of the Motor Fuel Tax Law.

Beginning with fiscal year 1991 and thereafter, no Road Fund monies shall be appropriated to the Department of State Police for the purposes of this Section in excess of its total fiscal year 1990 Road Fund appropriations for those purposes unless otherwise provided in Section 5g of this Act. It shall not be lawful to circumvent this limitation on appropriations by governmental reorganization or other methods unless otherwise provided in Section 5g of this Act.

In fiscal year 1994, no Road Fund monies shall be appropriated to the Secretary of State for the purposes of this Section in excess of the total fiscal year 1991 Road Fund appropriations to the Secretary of State for those purposes, plus \$9,800,000. It shall not be lawful to circumvent this limitation on appropriations by governmental reorganization or other method.

Beginning with fiscal year 1995 and thereafter, no Road Fund monies shall be appropriated to the Secretary of State for the purposes of this Section in excess of the total fiscal year 1994 Road Fund appropriations to the Secretary of State for those purposes. It shall not be lawful to

- circumvent this limitation on appropriations by governmental reorganization or other methods.
- 3 Beginning with fiscal year 2000, total Road Fund
- 4 appropriations to the Secretary of State for the purposes of
- 5 this Section shall not exceed the amounts specified for the
- 6 following fiscal years:
- 7 Fiscal Year 2000 \$80,500,000;
- 8 Fiscal Year 2001 \$80,500,000;
- 9 Fiscal Year 2002 \$80,500,000;
- 10 Fiscal Year 2003  $\frac{$64,400,000}{$89,500,000}$
- 11 Fiscal Year 2004 \$48,300,000
- 12 <u>Fiscal Year 2005</u> <u>\$32,200,000</u>
- 13 <u>Fiscal Year 2006</u> \$16,100,000
- 14 <u>Fiscal Year 2007</u> and
- each year thereafter  $\frac{\$0}{\$30,500,900}$ .
- 16 It shall not be lawful to circumvent this limitation on
- 17 appropriations by governmental reorganization or other
- 18 methods.
- No new program may be initiated in fiscal year 1991 and
- 20 thereafter that is not consistent with the limitations
- 21 imposed by this Section for fiscal year 1984 and thereafter,
- insofar as appropriation of Road Fund monies is concerned.
- Nothing in this Section prohibits transfers from the Road
- 24 Fund to the State Construction Account Fund under Section 5e
- 25 of this Act.
- 26 Beginning with fiscal year 2003 and thereafter, no Road
- Fund moneys may be appropriated to the Department of Central
- 28 <u>Management Services, the Department of Employment Security,</u>
- 29 <u>the Department of Revenue, the Court of Claims, or any other</u>
- 30 State agency (other than the Department of State Police and
- the Department of Transportation and, until fiscal year 2007,
- 32 the Secretary of State) for the purposes of this Section.
- 33 Appropriations to those entities for those purposes shall,
- instead, be made from the General Revenue Fund. It shall not

- 1 <u>be lawful to circumvent this limitation on appropriations by</u>
- 2 governmental reorganization or other methods. Nothing in
- 3 this paragraph prohibits appropriations from the Road Fund to
- 4 the Department of State Police for the purposes of the
- 5 <u>highway patrol budget only.</u>
- 6 Beginning with fiscal year 2007 and thereafter, no Road
- 7 Fund moneys may be appropriated to the Secretary of State for
- 8 the purposes of this Section. Appropriations to the
- 9 <u>Secretary of State for those purposes shall, instead, be made</u>
- 10 <u>from the General Revenue Fund</u>. Is shall not be lawful to
- 11 <u>circumvent this limitation on appropriations by governmental</u>
- 12 <u>reorganization or other methods</u>.
