- 1 AN ACT concerning enterprise zones.
- 2 Be it enacted by the People of the State of Illinois,
- 3 represented in the General Assembly:
- 4 Section 5. The Illinois Enterprise Zone Act is amended
- 5 by changing Section 5.3 as follows:
- 6 (20 ILCS 655/5.3) (from Ch. 67 1/2, par. 608)
- 7 Sec. 5.3. Certification of Enterprise Zones; Effective
- 8 date.
- 9 (a) Approval of designated Enterprise Zones shall be
- 10 made by the Department by certification of the designating
- 11 ordinance. The Department shall promptly issue a certificate
- 12 for each Enterprise Zone upon its approval. The certificate
- shall be signed by the Director of the Department, shall make
- 14 specific reference to the designating ordinance, which shall
- be attached thereto, and shall be filed in the office of the
- 16 Secretary of State. A certified copy of the Enterprise Zone
- 17 Certificate, or a duplicate original thereof, shall be
- 18 recorded in the office of recorder of deeds of the county in

7 (d) No more than 12 Enterprise Zones may be certified by 8 the Department in calendar year 1984, no more than 12 9 Enterprise Zones may be certified by the Department calendar year 1985, no more than 13 Enterprise Zones may be 10 11 certified by the Department in calendar year 1986, no more than 15 Enterprise Zones may be certified by the Department 12 in calendar year 1987, and no more than 20 Enterprise Zones 13 may be certified by the Department in calendar year 1990. In 14 15 other calendar years, no more than 13 Enterprise Zones may be 16 certified by the Department. The Department designate up to 8 additional Enterprise Zones outside the 17 regular application cycle if warranted by the 18 19 economic circumstances as determined by the Department. The Department may also designate one additional Enterprise 20 21 outside the regular application cycle if an aircraft 22 manufacturer agrees to locate an aircraft manufacturing 23 facility in the proposed Enterprise Zone. Notwithstanding any other provision of this Act, no more than 89 Enterprise Zones 24 25 may be certified by the Department for the 10 calendar years commencing with 1983. The 7 additional Enterprise Zones 26 authorized by Public Act 86-15 27 shall not lie municipalities or unincorporated areas of counties that abut 28 29 or are contiguous to Enterprise Zones certified pursuant to 30 this Section prior to June 30, 1989. The 7 additional Enterprise Zones (excluding the additional Enterprise Zone 31 32 which may be designated outside the regular application cycle) authorized by Public Act 86-1030 shall not lie within 33

municipalities or unincorporated areas of counties that abut

- or are contiguous to Enterprise Zones certified pursuant to

- 27 Section 10. The Public Utilities Act is amended by
- 28 changing Section 9-222.1 as follows:
- 29 (220 ILCS 5/9-222.1) (from Ch. 111 2/3, par. 9-222.1)
- 30 Sec. 9-222.1. A business enterprise which is located
- 31 within an area designated by a county or municipality as an
- 32 enterprise zone pursuant to the Illinois Enterprise Zone Act

or located in a federally designated Foreign Trade Zone or Sub-Zone shall be exempt from the additional charges added to the business enterprise's utility bills as a pass-on of municipal and State utility taxes under Sections 9-221 and 9-222 of this Act, to the extent such charges are exempted by ordinance adopted in accordance with paragraph (e) of Section 8-11-2 of the Illinois Municipal Code in the case of municipal utility taxes, and to the extent such charges are exempted by the percentage specified by the Department of Commerce and Community Affairs in the case of State utility taxes, provided such business enterprise meets the following criteria:

- (1) it either (i) makes investments which cause the creation of a minimum of 200 full-time equivalent jobs in Illinois; (ii) makes investments of at least \$175,000,000 which cause the creation of a minimum of 150 full-time equivalent jobs in Illinois; or (iii) makes investments which cause the retention of a minimum of 1,000 full-time jobs in Illinois; and
- (2) it is either (i) located in an Enterprise Zone established pursuant to the Illinois Enterprise Zone Act or (ii) it is located in a federally designated Foreign Trade Zone or Sub-Zone and is designated a High Impact Business by the Department of Commerce and Community Affairs; and
- (3) it is certified by the Department of Commerce and Community Affairs as complying with the requirements specified in clauses (1) and (2) of this Section.

The Department of Commerce and Community Affairs shall determine the period during which such exemption from the charges imposed under Section 9-222 is in effect which shall not exceed 30 20 years,-except-in-the-case-of-the-Whiteside County/Carroll-County-Enterprise--Zone,--where,--solely--with respect-to-industrial-purposes-and-uses,-the-exemption-period

shall--not--exceed-3θ-years,-and-shall-specify-the-percentage

of-the-exemption-from-State-utility-taxes.

The Department of Commerce and Community Affairs shall 3 4 have the power to promulgate rules and regulations to carry out the provisions of this Section including procedures for 5 6 complying with the requirements specified in clauses (1) and 7 (2) of this Section and procedures for applying for the exemptions authorized under this Section; to define the 8 9 amounts and types of eligible investments which business enterprises must make in order to receive State utility tax 10 11 exemptions pursuant to Sections 9-222 and 9-222.1 of this Act; to approve such utility tax exemptions for business 12 enterprises whose investments are not yet placed in service; 13 require that business enterprises granted tax 14 15 exemptions repay the exempted tax should the 16 enterprise fail to comply with the terms and conditions of the certification. However, no business enterprise shall be 17 required, as a condition for certification under clause (3) 18 19 of this Section, to attest that its decision to invest under clause (1) of this Section and to locate under clause (2) of 20 2.1 this Section is predicated upon the availability of the 22 exemptions authorized by this Section.

A business enterprise shall be exempt, in whole or in part, from the pass-on charges of municipal utility taxes imposed under Section 9-221, only if it meets the criteria specified in clauses (1) through (3) of this Section and the municipality has adopted an ordinance authorizing the exemption under paragraph (e) of Section 8-11-2 of the Illinois Municipal Code. Upon certification of the business enterprises by the Department of Commerce and Community Affairs, the Department of Revenue of such certification. The Department of Revenue of such certification of the exemption status of business enterprises from the
